3. Ordinance establishing a speed limit of ten (10) mile per hour on West 223rd Street, "Speed Checked by Radar" and Caution Children at Play", Ward (10), District (9) of Lafourche Parish; requiring the placement of "Speed Limit, "Speed Checked by Radar" and "Caution Children at Play" signs; and providing penalties for the violations thereof.
4. Ordinance to amend and re-enact the Code of Ordinances of the Lafourche Parish Council as it pertains to open burning in Lafourche Parish and the permitting of said burns.
5. Ordinance to amend Ordinance No. 3383 to change Section 3 as it pertains to the date, time, and place for the first meeting of the Lafourche Parish Home Rule Charter Revision Commission.
