**WHEREAS,** the Home Rule Charter allows the Parish President to appoint not more than one deputy director under each department; and

**WHEREAS,** amendments presented in this ordinance represents the addition of the salary of the Deputy Director of Public Works; and



**WHEREAS,** because their have been unfilled positions within this department, it will not be necessary to adjust the 2008 Operations and Maintenance Budget to approve the increase.

**BE IT ORDAINED,** by the Lafourche Parish Council, convened in Regular Session on \_\_\_\_\_, that:

**SECTION 1.** The Maintenance and Operations Budget for the Lafourche Parish Council is hereby amended as follows:
