A RESOLUTION APPROVING THE PARISH PRESIDENT'S APPOINTMENT OF DR. JOHN KING TO SERVE AS LAFOURCHE PARISH CORONER UNTIL A SPECIAL ELECTION IS HELD ON OCTOBER 4 AND NOVEMBER 4, 2008, AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ALL RELEVANT DOCUMENTS.

WHEREAS, as required by Louisiana R.S. 33:1551, Lafourche Parish must have a Coroner; and

WHEREAS, Dr. Coleridge T. Franklin, Jr., Coroner, Parish of Lafourche, resigned as Lafourche Parish Coroner effective May 28, 2008; and

WHEREAS, a special election will be held on October 4 and November 4, 2008, with qualifying July 9-11, 2008; and

WHEREAS, an appointee is needed to serve as Parish Coroner until said special election is held; and

WHEREAS, upon the recommendation of Dr. Franklin, Parish President Charlotte Randolph, hereby appoints Dr. John King to serve as Parish Coroner until said special election is held; and
