1. **PROPOSED ORDINANCE providing for a 2011 Supplemental Appropriation (11-033) within the 2011 Operations and Maintenance Budget and the 2011 Capital Budget to fund the repair of the Ferd H. Block Building Balcony, the relocation of LA1 and Highway 24 Connection, and de-obligate funding of the East 1ST and 2ND Streets Drainage Project** and authorizing the Parish President to sign, execute and administer said transactions as provided for by Article VI of the Lafourche Parish Home Rule Charter. ORDINANCE PROVIDING FOR A 2011 SUPPLEMENTAL APPROPRIATION (11-033) WITHIN THE 2011 OPERATIONS AND MAINTENANCE BUDGET AND THE 2011 CAPITAL BUDGET TO FUND THE REPAIR OF THE FERD H. BLOCK BUILDING BALCONY, THE RELOCATION OF LA1 AND HIGHWAY 24 CONNECTION, AND DE-OBLIGATE FUNDING OF THE EAST 1ST AND 2ND STREETS DRAINAGE PROJECT AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID TRANSACTIONS AS PROVIDED FOR BY ARTICLE VI OF THE LAFORCHE PARISH HOME RULE CHARTER.

WHEREAS, administration has determined it necessary to repair the Ferd H. Block Building Balcony (project 11049); funding in the amount of \$20,000 will be transferred from Building and Maintenance (Fund 102); and

WHEREAS, administration has determined it is necessary to relocate the LA1 and Highway 24 connection (project 11050): funding in the amount of \$50,000 will be transferred from Road Sales Tax District 2 (Fund 161); and

WHEREAS, administration has determined it is necessary to de-obligate funding from the East 1st and 2nd Street Drainage Project (project 11007); funding in the amount of \$75,578.96 will be transferred from Capital Outlay Road Sales Tax District 2 (Fund 201); and

WHEREAS, this ordinance was sponsored for Administration by Mr. Phillip Gouaux, Councilman, District 7; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the council approve the above adjustments of the 2011 Operations and Maintenance and Capital Budgets and authorizes the Parish President to sign, execute, and administer said transactions as provided for by Article VI of the Lafourche Parish Home Rule Charter.



THEREFORE BE IT ORDAINED, by the Lafourche Parish Council, convened in Regular Session on _____, and hereby authorizes the Parish President to sign,

execute, and administer said transactions as provided for by Article VI of the Lafourche Parish Home Rule Charter; and

BE IF FURTHER ORDAINED, that:

SECTION 1. A supplemental appropriation of the 2011 Operations and Maintenance Budget is hereby approved as follows:

FUND 102 – BUILDING & MAINTENANCE

To fund repairs to the Ferd H. Block Building balcony (project 11049);

1. an increase in TRANSFERS OUT to fund 299 in the amount of \$20,000

FUND 161 – ROAD SALES TAX DISTRICT 2

To de-obligate funding from the East 1st and 2nd Streets drainage project (project 11007);

1. an decrease in TRANSFERS OUT to fund 201 in the amount of \$75,578.96

To fund the LA1 and Highway 24 relocation project (project 11050);

2. an increase in TRANSFERS OUT to fund 201 in the amount of \$50,000

SECTION 2. A supplemental appropriation of the 2011 Capital Budget is hereby approved as follows:

FUND 201 CAPITAL PROJECTS – ROAD SALES TAX DISTRICT 2

To fund repairs to the Ferd H. Block Building balcony – project 11049.

1. an increase in TRANSFERS IN from fund 102 in the amount of \$20,000
2. an increase in CAPITAL OUTLAY in the amount of \$20,000

To de-obligate funding from the East 1st and 2nd Streets drainage project:

1. a decrease in TRANSFERS IN from fund 161 in the amount of \$75,578.96
2. a decrease in CAPITAL OUTLAY in the amount of \$75,578.96

To fund the LA1 and Highway 24 relocation project:

1. an increase in TRANSFERS IN from fund 161 in the amount of \$50,000
2. an increase in PROFESSIONAL SERVICES in the amount of \$50,000

SECTION 3. If any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or application of this ordinance which can be given affect without the invalid provisions, items or application, and to this end the provisions of this ordinance are declared severable.

SECTION 4. All Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

SECTION 5. This Ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

ITEM 1

SECTION 6. A certified copy of this ordinance shall be forwarded to Lafourche Parish Government's Finance Department, Department of Public Works, Department of Building and Maintenance, and the Office of the Parish Administrator.

SECTION 7. This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said council, was then submitted to an official vote as a whole, the vote thereon being as follows:
