AVAILABILITY OF LOW INCOME ENERGY ASSISTANCE FUNDS (LIHEAP)

Lafourche Parish Office of Community Action is announcing the availability of funds dedicated to assist eligible low income households with their energy payments. All applications are taken on a first come, first served basis by appointments only. Applications will be taken beginning **January 23, 2012**. An eligible household is one whose total income is at or below the levels listed in the table below and who have not received a previous benefit within the past six months. Applicants must provide, at a minimum, the following documentation at the time the application is taken:

- (1) Copies of each household member’s social security number
- (2) Proof of income of all household members age 18 or older
- (3) A copy of an energy bill (must be within the last 12 months)
- (4) A photo I.D. of the applicant
- (5) Another document which was mailed to the applicant at the service address indicated on the energy bill and which lists the same address as the service address on the energy bill.

If it is determined additional documentation is required the applicant will be notified at the time of application. Households reporting Zero Income must provide additional documentation. All information provided is subject to verification. Intentional misrepresentation of information may result in criminal prosecution of the applicant and anyone assisting in the misrepresentation.

Applications are taken by appointment only. To schedule an appointment you may call: **(the number listed below closes to your resident). Appointments will be taken on the day listed below only.** Applicants coming to the office without an appointment will be scheduled for appointment and instructed to return on their appointment date. Income eligible applicants who have received a Disconnect Notice and who have not received assistance for a Disconnect Notice in the prior 12 months may also apply. **All above information must be presented at the time of appointment; otherwise application will not be taken. The client must reschedule their appointment.**
