EARLY PUBLIC REVIEW NOTICE**

(Thibodaux, La.) -- This is to give notice that the Lafourche Parish Government has conducted an evaluation as required by Executive Order 11988, in accordance with HUD regulations at 24 CFR 55.20 Subpart C, to determine the potential affect by the 100-year flood plain of this action and seeks to involve the public in the decision making process.

The Lafourche Parish Government is interested in alternatives and public perceptions of possible adverse impacts that could result from the project as well as potential mitigation measures. The Lafourche Parish Government is proposing to develop no more than ten units of affordable rental housing for low and moderate income persons. The Housing Authority of Lafourche Parish will be the subrecipient for the purpose of project implementation. The funds will be from the Louisiana Community Development Block Grant Program, Hurricanes Gustav and Ike, Parish-Implemented Recovery Program. The proposed project will be at the following location:
