Sub-Chapter A

In General

SECTION 2:1. ADOPTION OF HOME RULE CHARTER; EFFECTIVE DATE OF CHARTER; DESIGNATION OF GOVERNING BODY

A. The Parish of Lafourche, State of Louisiana shall operate and function under the Plan of Government and Home Rule Charter adopted at the public referendum on August 14, 1976. The provisions of the Charter pertaining to the organization, structure and distribution of powers and functions of the governing authority created thereunder shall go into effect on June 2, 1980, at the end of the term of the members of the Lafourche Parish Police Jury elected in 1975. The remaining provisions of the Charter shall become effective at midnight on October 1, 1976, which date was the thirteenth day after the date on which the election results were promulgated by the appropriate election officials certifying adoption of the Charter.

B. The governing authority of Lafourche Parish shall be the Lafourche Parish Council, the members of which shall be elected as set forth in Sections 2:2.2 and 2:3 of this Code.

Comment -- Up until 1976, the Parish of Lafourche has operated under the general police jury form of government as set forth in state law. Acting under the authority of Article VI, Section 5 of the Louisiana Constitution of 1974, on February 12, 1975, the Police Jury created a commission to prepare and propose a home rule charter for the parish and this commission completed its work in the spring of 1976. The propose charter developed by the commission was submitted to a public referendum on August 14, 1976 and was approved by a majority of those voting at that election. The Charter was amended by public referendum on 1/17/98. Amendments pertaining to the organization and structure of the governing authority do not take effect until noon on January 12, 2000. The remaining amendments became effective at midnight on March 12, 1998 which was the thirtieth day after the date of promulgation of the election results by the appropriate election officials certifying adoption of the Charter.

The contents of this amended Charter are set forth in Appendix "A" of this Code.

SECTION 2:2. DIVISION OF PARISH INTO PUBLIC HEARING REGIONS

A. The Parish of Lafourche, State of Louisiana, shall be divided into three (3) Public Hearing Regions, as follows:

§ 2:2

1. The North Lafourche Region shall comprise the Lafourche-Assumption Parish line on the north to the St. Charles Bridge across Bayou Lafourche on the south. The communities of Choctaw, Kraemer and Bayou Boeuf shall be included in the North Lafourche Region.

2. The Central Lafourche Region shall comprise that area from the St. Charles Bridge across Bayou Lafourche on the north to the Intracoastal Waterway on the south. The Bayou Blue and Des Allemands area shall be included in the Central Lafourche Region.

3. The South Lafourche Region shall comprise that area from the Intracoastal Waterway on the north to the southern most boundary of the parish. The Grand Bois and Point Au Chene communities shall be included in the South Lafourche Region.

B. These regions are created for the purpose of conducting regional public hearings in the parish in accordance with the provisions of Article IV, Section B, Paragraph 5(b) of the Lafourche Parish Home Rule Charter.

SECTIONS 2:3 - 2:89. RESERVED

SECTION 2:90. DEFINITION OF PARISH COURTHOUSE

It is hereby provided that the Lafourche Parish Courthouse consists of the old courthouse building in Thibodaux, Louisiana, and the Lafourche Parish Courthouse Annex Building in Thibodaux, Louisiana. The Lafourche Parish Annex Building in Galliano, Louisiana, is designated a courthouse for the purposes of LRS 13:501 and Article 672 of the Code of Criminal Procedure and it may be used for all auxiliary functions of the parish government not prohibited by the Lafourche Parish Home Rule Charter, or the state constitution, or law. SECTIONS 2:91 - 2:94. RESERVED

SECTION 2:95. RESTRICTIONS ON SMOKING IN PUBLIC BUILDINGS VIOLATIONS, PENALTIES

A. Except as otherwise allowed herein, smoking is prohibited in all enclosed areas of public buildings owned or occupied by the Lafourche Parish Council or agency, commission or entity thereof.

B. Notwithstanding any other provisions of this section, smoking shall be permitted in designated smoking areas which shall be so situated as to allow non-smoking individuals the opportunity to conduct normal activity in a reasonably smoke-free environment.

C. It shall be unlawful for any person to smoke in any area where smoking is prohibited by the provisions of this section.

D. Any person who violates the provisions of this section shall be subject to a misdemeanor summons and a fine not to exceed one hundred dollars (\$100.00).

E. Any person or employer who owns, manages, operates or otherwise controls the use of any premises subject to this section shall designate smoking areas, where appropriate, and signs identifying the area accordingly.

F. The "smoking" or "no smoking" signs, whichever are appropriate, or the international "no smoking" symbol (consisting of a pictorial representation of a burning cigarette enclosed in a red circle with a red bar across it) shall be clearly and conspicuously posted by the owner, operator, manager, employer or other person in control of every place where smoking is controlled by this section.

SECTION 2:96. RESTRICTIONS ON SMOKING IN PARISH COUNCIL CHAMBERS

A. It shall be unlawful for any person to smoke in the chambers of the Lafourche Parish Council located on the second floor of the Old Courthouse Building, Thibodaux, Louisiana.

B. "No Smoking" signs shall be placed in the Lafourche Parish Council chambers upon the effective date of this section.

C. Any person who violates the provisions of this section shall upon conviction thereof, be punished by imprisonment in the parish jail for a period of not more than thirty (30) days, or by fine of not more than five hundred dollars (\$500.00) or by both such imprisonment and fine, at the discretion of the court.

SECTION 2:97. PARISH LOGO REQUIRED ON ALL LAFOURCHE PARISH VEHICLES AND EQUIPMENT

A. Every boat, water craft, automobile, truck, equipment, or other vehicles belonging to the parish or to any of its political subdivisions, or to any department, board, commission, or agency of its political subdivisions shall have inscribed, painted, decaled, or stenciled conspicuously thereon, either with letters not less than two inches in height and not less than one-quarter inch in width or with an insignia containing not less than one hundred forty-four square inches, or if circular, not less than eight inches in diameter, the name of the board, commission, department, agency, or subdivision of the parish to which the boat, water craft, automobile, truck, equipment, or other vehicles belong.

B. The name of the board, commission, department, agency or political subdivision, shall be placed on the outside of the door on each side of every automobile, truck, or other vehicle. If the vehicle is equipped with more than one door on each side, the name shall be placed on the outside of the doors nearest the front of the vehicle.

C. All paintings, inscriptions or stencils shall be in a color that contrasts sharply with the color over which it is placed.

D. The individual whose responsibility it is to place the purchase order for any vehicle as herein provided shall be personally responsible for seeing that the agency name is placed thereon as herein required and shall do so within ten (10) days after the delivery of such vehicle or water craft.

E. The head of any department or board of the parish or any of its subdivisions who operates or who orders, requests or permits any employee under his supervision or any other person to operate any publicly owned land vehicle not marked in accordance with the provisions of this ordinance shall be guilty of a violation thereof.

Sub-Chapter B

Elections

SECTION 2:100. IN GENERAL

A. Adoption of Permanent Voter Registration System

1. In accordance with the provisions of Section 2 of Act 415 of the Louisiana Legislature of 1952 (LRS 18:224), the Parish of Lafourche does hereby elect, in the matter of registration of voters, to be governed by the provisions of Act 415 of the Louisiana Legislature of 1952 insofar as the provisions of said act may be pertinent and applicable to the Parish of Lafourche.

2. In accordance with the provisions of Act 415 of 1952, the pertinent and applicable provisions shall become effective in the Parish of Lafourche on August 1, 1953.

3. The registrar of voters of the Parish of Lafourche shall be furnished with a certified copy of this resolution and he is hereby authorized, empowered and directed to obtain those supplies, forms and equipment for the operation and conduct of his office and the maintenance of the records required and specified by the provisions of aforesaid Act 415 of 1952.

B. Items on Ballots at a General Election or State Election; and Providing for Emergency Situations.

1. Due to the cost of elections, Lafourche Parish will only have items on ballots at a general election or a State election.

2. In an emergency situation, the Lafourche Parish Council can grant the authority to hold a special election by the adoption of a resolution.

SECTION 2:101. DIVISION OF PARISH INTO WARDS AND PRECINCTS

The Parish of Lafourche shall be divided into eleven (11) wards and sixty-two (62) precincts described as follows, to wit:

Beginning at the intersection of the Terrebonne/Lafourche and Assumption/Lafourche Parish lines, thence northeasterly along the Assumption/Lafourche Parish line to its intersection with Bayou Lafourche, thence easterly along Bayou Lafourche to its intersection with LA 3185 (Thibodaux Bypass Road), thence southerly along LA 3185 to its intersection with the Southern Pacific Railroad, thence westerly along the Southern Pacific Railroad to its intersection with Waverly Road, thence southerly along Waverly Road to its intersection with LA 3107 (Talbot Avenue), thence westerly a short distance along LA 3107 (Talbot Avenue) to its intersection with an unnamed drainage canal west of Waverly Rd., thence southwesterly along said drainage canal to its intersection with the 80 Arpent Canal, thence easterly along the 80 Arpent Canal to its intersection with the Terrebonne/Lafourche Parish line, thence southerly and westerly along said parish line to its intersection with the Assumption/Lafourche Parish line, the point of beginning.

WARD 1 PRECINCT 2

Beginning at the intersection of LA 3107 (Talbot Ave.) and Waverly Road, thence northerly along Waverly Road to its intersection with the Southern Pacific Railroad Track Right of Way, thence southeasterly along said railroad track right of way to its intersection with LA 3185 (Thibodaux Bypass Road), thence southerly along LA 3185 (Thibodaux Bypass Road) to its intersection with LA 3107 (Talbot Avenue), thence easterly along LA 3107 (Talbot Avenue) to its intersection with Veterans Blvd., thence southerly along Veterans Blvd. to its intersection with LA 3185, thence easterly along LA 3185 to its intersection with the Terrebonne/Lafourche Parish line, thence southwesterly along said parish line to its intersection with the 80 Arpent Canal, thence northwesterly along the 80 Arpent Canal to its intersection with an unnamed drainage canal west of Waverly Road, thence northeasterly along said canal to its intersection with LA 3107 (Talbot Ave.), thence easterly along LA 3107 (Talbot Ave.) to its intersection with Waverly Road, the point of beginning.

WARD 1 PRECINCT 3A AND 3B

Beginning at the intersection of LA 3107 and LA 3185, thence northerly along LA 3185 (Thibodaux Bypass Road), to its intersection with Bayou Lafourche, thence easterly along Bayou Lafourche to its intersection with the straight line extension of St. Bernard Street; thence south along the straight line extension of St. Bernard Street to its intersection with 1st Street; thence east along 1st Street to its intersection with Oak Lane; thence south along Oak Lane to its intersection with Wilson Street; thence east along Wilson Street to its intersection with Barbier Avenue; thence south along Barbier Avenue to its intersection with Leonard; thence west along Leonard to its intersection with St. Bernard Street; thence south on St. Bernard to its intersection with LA 3107 (Talbot Avenue), thence westerly along LA 3107 (Talbot Avenue) to its intersection with LA 3185 (Thibodaux Bypass Road), the point of beginning.

WARD 1 PRECINCT 4

Beginning at the intersection of LA 3185 and Veterans Blvd., thence northerly along Veterans Blvd. to its intersection with LA 3107 (Talbot Avenue), thence easterly along LA 3107 (Talbot Avenue) to its intersection with Louise Street, thence north along Louise Street to its intersection with Southern Pacific Railroad, thence easterly along the Southern Pacific Railroad to its intersection with Ridgefield Road, thence southwesterly along Ridgefield Road to its intersection with LA 3107 (Talbot Avenue), thence easterly along LA 3107 (Talbot Avenue) to its intersection with the Terrebonne/Lafourche Parish line, thence southerly along said Parish line to its intersection with LA 3185 (Thibodaux Bypass Road), thence westerly along LA 3185 (Thibodaux Bypass Road) to its intersection with Veterans Blvd., the point of beginning.

WARD 2 PRECINCT 1

Beginning at the intersection of LA Hwy. 3266 (Old Coulon Plantation Road) and Bayou Lafourche, thence northerly along LA Hwy. 3266 to its intersection with the Missouri Pacific Railroad, thence east along the Missouri Pacific Railroad to its intersection with Lafourche Drive, thence south along Lafourche Drive to its intersection with Bayou Lafourche, thence west along Bayou Lafourche to its intersection with LA Hwy. 3266 (Old Coulon Plantation Road), the point of beginning.

WARD 2 PRECINCT 1A

Beginning at the intersection of LA Hwy. 3266 (Old Coulon Plantation Road) and the Missouri Pacific Railroad, thence northerly along LA Hwy. 3266 (Old Coulon Plantation Road) to its intersection with 40 Arpent Road, thence east along the 40 Arpent Road to its intersection with St. Patrick Street, thence south along St. Patrick Street to its intersection with Bayou Lafourche, thence west along Bayou Lafourche to its intersection with Lafourche Drive, thence northerly along Lafourche Drive to its intersection with the Missouri Pacific Railroad, thence westerly along the Missouri Pacific Railroad to its intersection with LA Hwy. 3266 (Old Coulon Plantation Road), the point of beginning.

WARD 2 PRECINCT 2

Beginning at the intersection of Bayou Lafourche and St. Patrick Street, thence north along St. Patrick Street to its intersection with LA Highway 20, thence north along LA highway 20 to its intersection with 80 Arpent Canal, thence easterly along the 80 Arpent Canal to its intersection with an unnamed stream that is the dividing line between sections 82 and 83, T14S-R16E, thence southwest along said unnamed stream to its intersection with the 40 Arpent Road, thence east along 40 Arpent Road to its intersection with Paul Lane, thence southwest along Paul Lane to its intersection with LA Hwy. 308, thence southeast along LA Hwy. 308 to its intersection with Audubon Street Bridge, thence south along Audubon Street Bridge to its intersection with Bayou Lafourche, thence west along Bayou Lafourche to its intersection with St. Patrick Street, the point of beginning.

WARD 2 PRECINCT 3

Beginning at the intersection of Barbier Avenue and its intersection with Cedar Street, thence northerly on Barbier Avenue to its intersection with Wilton Street, thence westerly on Wilton Street to its intersection with Oak Lane, thence northerly on Oak Lane to its intersection with 1st Street, thence westerly on 1st Street to its intersection with St. Bernard Street, thence northerly on St. Bernard Street and its extension to its intersection with Bayou Lafourche, thence easterly along Bayou Lafourche to its intersection with the straight line extension of Alwes Street, thence southerly along Alwes Street to its intersection with Cherry Street, thence easterly along Cherry Street to its intersection with Arms Street, thence southerly along Arms Street to its intersection with the Southern Pacific railroad tracks, thence westerly along said tracks to its intersection with Tiger Drive, thence northerly a short distance along Tiger Drive to its intersection with Parish Road, thence westerly along Parish Road to its intersection with Notre Dame Street, thence northerly along Notre Dame Street to its intersection with Cedar Street, thence easterly along Cedar Street to its intersection with Tiger Drive, thence northerly along Tiger Drive to its intersection with St. Mary Highway (LA 1), thence westerly along St. Mary Highway (LA 1) to its intersection with Rubyat Drive, thence southerly along Rubyat Drive to its intersection with Government Circle, southerly around Government Circle to its intersection with Cedar Street, thence westerly along Cedar Street to its intersection with Barbier Avenue, the point of beginning.

WARD 2 PRECINCT 6

Beginning at the intersection of Jackson Street and Bayou Lafourche, thence easterly along Bayou Lafourche to its intersection with the Audubon Street Bridge, thence southerly along Audubon Street to its intersection with LA Hwy. 1, thence westerly along LA Hwy. 1 to its intersection with Elder Street, thence southerly along Elder Street to its intersection with Tetreau Street, thence southerly along Tetreau Street to its intersection with East 12th Street, thence westerly along East 12th Street to its intersection with McCulla Street, thence northerly along McCulla Street to its intersection with East 7th Street, thence westerly along East 7th Street to its intersection with Canal Street (LA 20), thence southerly along Canal Street to its intersection with West 10th Street, thence westerly along West 10th Street to its intersection with Jackson Street, thence northerly along Jackson Street to its intersection with Bayou Lafourche, the point of beginning.

Beginning at the intersection of Back Street and Ledet Street; thence west along Back Street to its intersection with Tetreau Street; thence north along Tetreau Street to its intersection with E. 12th Street; thence west along East 12th Street to its intersection with Tetreau Street, thence northerly along Tetreau Street to its intersection with Elder Street; thence northeast along Elder Street to its intersection with LA Hwy. 1; thence east along LA Hwy. 1 to its intersection with Audubon Avenue; thence southerly along Audubon Avenue to its intersection with an unnamed drainage ditch located at 90°48'21.96"W and 29°47'16.39"N; thence westerly along said ditch to its intersection with an unnamed drainage canal parallel to Bayou Lane located at 90°48'37.75W and 29°47'22.55N, thence southwestwesterly along said canal to its intersection with the Southern Pacific Railroad Tracks; thence northwestwesterly and westerly along the centerline of the Southern Pacific Railroad Tracks to its intersection with the centerline of Ledet Street; thence, northwestwesterly along Ledet Street to its intersection with the centerline of Back Street, the point of beginning.

WARD 2 PRECINCT 11

**SECTION 2:175. DIVISION OF PARISH INTO JUSTICE OF THE PEACE DISTRICTS;
QUALIFICATIONS OF JUSTICES AND CONSTABLES**

A. The Parish of Lafourche, State of Louisiana, shall be divided into four (4) Justice of the Peace Districts, as follows:

1. The First Justice District shall comprise Wards One, Two, Five and Six.
2. The Second Justice District shall comprise Wards Three, Seven and Eleven.
3. The Third Justice District shall comprise Wards Four, Eight and Nine.
4. The Fourth Justice District shall comprise Ward Ten.

B. This Section shall become effective upon the lawful assumption of office of the Justices of the Peace and Constables in the aforementioned Justice Districts subsequent to the 1975 election for said offices; provided, however, that for the purpose of qualifying for election to the office of Justice of the Peace or Constable of the Second Justice District in the 1975 elections and thereafter, a candidate shall be a resident of either Ward Three, Seven or Eleven, and a candidate for said offices in the Third Justice District shall be a resident of either Ward Four, Eight or Nine, in addition to possession all other requirements established by law.

Sub-Chapter C

Provisions Governing Operations of Parish Governing Body

Part I — In General

SECTION 2:200. MEETINGS OF THE PARISH COUNCIL

A. Regular meetings of the Lafourche Parish Council will be held on the second and fourth Tuesday of the month at 5:00 p.m. in the Council meeting room at the Barrios Center, Raceland, Louisiana. By a favorable vote of at least five (5) members, regular or special meetings may be held at other locations within the Parish of Lafourche. Meetings will be publicly advertised as required by law.

B. The agenda for all regular meetings shall be mailed in final form the Thursday preceding the meeting. Only agenda items submitted by 4:30 p.m. seven days prior to the meeting date will be discussed at the meeting unless a suspension of rules is approved by six (6) members of the Council. All two-third items must be submitted to the Council Clerk by 4:30 PM the day prior to the meeting.

C. Special meetings may be held on call of the Chair or any three (3) members and upon no less than twenty-four (24) hours notice to each member, unless waived by a two-thirds majority of the members of the governing authority. The notice for a special meeting must be signed by the Chair or by the members calling the meeting, shall state the purpose of the meeting, and shall be served on each member personally or at the member's domicile. Service may be made by any police officer of the Parish or any municipality therein. At a special meeting only matters specified in the call shall be considered. All regular and special meetings shall be open to the public.

1. All special meetings of the Lafourche Parish Council shall be held at any time deemed necessary.

SECTION 2:201. PARISH ADMINISTRATOR

A. The Parish Administrator shall have direct authority over all Parish department heads and employees, as well as, control over the daily operations of the Parish. He/She shall set the compensation of all Parish employees.

B. This authority shall be exercised and carried out at the direction of the Parish President in accordance with the legislative policies established by the Parish Council and the Home Rule Charter.

SECTION 2:202. GENERAL LEGISLATIVE RULES OF PROCEDURE OF THE PARISH GOVERNING AUTHORITY

A. A written agenda will be followed for all Council meetings. Regular meeting agendas can be suspended by a vote of two-thirds of the members present for specific requests.

§ 2:202

B. Complete minutes of the meeting shall be prepared and mailed to all Council members with the agenda for the following meeting.

C. Five (5) Council members, excluding the President, shall constitute a quorum for the transaction of business.

**SECTION 2:203. PARISH EXECUTIVE DEPARTMENTS; FINANCE;
PUBLIC WORKS; HUMAN RESOURCES; COMMUNITY
SERVICES**

A. A *Department of Finance* is hereby created and established. The head of this department shall be the Director of Finance. He/she shall administer all financial matters of the Council and shall be responsible for payroll, purchasing, bookkeeping, and accounts receivable and payable. He/she shall give an oral monthly report of the parish finances at the second Lafourche Parish Council meeting and shall provide financial statements to all Council members monthly. It shall be the responsibility of each Council Member to establish the types and styles of finance reports. He/she shall perform such duties as may be prescribed by the Parish President, Parish Administrator, the Lafourche Parish Home Rule Charter, or by ordinance. The Parish President may appoint Deputy Director(s) of Finance that will serve outside of the Civil Service System, as provided by the Lafourche Parish Home Rule Charter and as approved by the Council.

B. A *Department of Public Works* is hereby created and established. The head of this department shall be the Director of Public Works. He/she shall be responsible for the field operations of all employees in the department, the maintenance and operation of all road and drainage infrastructure and equipment. He/she shall perform such duties as may be prescribed by the Parish President, Parish Administrator, the Lafourche Parish Home Rule Charter, or by Ordinance. The Parish President may appoint Deputy Director(s) of Public Works that will serve outside of the Civil Service System, as provided by the Lafourche Parish Home Rule Charter and as approved by the Council.

C. A *Human Resources Department* is hereby created and established. The head of this department shall be the Director of Human Resources. He/she shall administer the operations of the Human Resources Department and shall perform such duties as may be prescribed by the Parish President, Parish Administrator, the Lafourche Parish Home Rule Charter, or by Ordinance. The Parish President may appoint Deputy Director(s) of Human Resources that will serve outside of the Civil Service System, as provided by the Lafourche Parish Home Rule Charter and as approved by the Council.

D. A *Department of Community Services* is hereby created and established. The head of this department shall be the Director of Community Services. He/she shall coordinate the various special services and programs as may be developed and/or designated to improve social services to the community. Duties as may be prescribed by the Parish President, Parish Administrator, the Lafourche Home Rule Charter, or by Ordinance. The Parish President may appoint Deputy Director(s) of Community Services that will serve outside of the Civil Service System, as provided by the Lafourche Parish Home Rule Charter and as approved by the Council.

E. A *Department of Grants and Economic Development* is hereby created and established. The head of this department shall be the Director of Grants and Economic Development. He/She shall administer the operations of the Department; coordinate a grants section to enhance funding opportunities and a development section to provide for planning and economic development. He/She shall perform such duties as may be prescribed by the Parish President, Parish Administrator, the Lafourche Parish Home Rule Charter, or by Ordinance. The Parish President may appoint Deputy Director(s) of Grants and Development that will serve outside of the Civil Service System, as provided by the Lafourche Parish Home Rule Charter and as approved by the Council.

F. A *Department of Parks, Recreation and Public Facilities* is hereby created and established. The head of this department shall be the Director of Facilities. He/She shall be responsible for the field operations of all employees in the department, the maintenance and operation of all Parish parks and buildings. He/She shall perform such duties as may be prescribed by the Parish President, Parish Administrator, the Lafourche Parish Home Rule Charter, or by Ordinance. The Parish President may appoint Deputy Director(s) of Parks, Recreation, and Public Facilities that will serve outside of the Civil Service System, as provided by the Lafourche Parish Home Rule Charter, and as approved by the Council.

G. A *Department of Coastal, Energy, and Environment* is hereby created and established. The head of this department shall be the Director of Coastal, Energy, and Environment. He/She shall coordinate projects and programs relative to coastal, energy and environmental matters on behalf of the Parish. He/She shall administer the operations of his/her department and perform such duties as may be prescribed by the Parish President, Parish Administrator, the Lafourche Parish Home Rule Charter or by Ordinance. The Parish President may appoint Deputy Director(s) of Coastal, Energy, and Environment that will serve outside of the Civil Service System, as provided by the Lafourche Parish Home Rule Charter and as approved by the Council.

SECTION 2:204. FISCAL YEAR

A. The Council's fiscal year shall be the calendar year.

SECTION 2:205. PARISH PRESIDENT'S SALARY

The annual salary of the Parish President is \$65,000.00.

Comment – Amendments to the Home Rule Charter were approved by the electors on November 2, 2004 and became effective 1/1/05. The changes raised the annual salary of the Parish President to \$65,000 to be effective on the effective date of the ordinance, provided the ordinance is adopted prior to 7/1/05.

SECTION 2:207. REIMBURSEMENT OF TRAVEL EXPENSES FOR MEMBERS OF THE LAFOURCHE PARISH COUNCIL, COUNCIL EMPLOYEES, THE PARISH PRESIDENT, ADMINISTRATIVE EMPLOYEES, MEMBERS OF PARISH BOARDS AND THEIR EMPLOYEES

A. Members of the Lafourche Parish Council, Council employees, the Parish President, Administrative employees, members of Parish boards and their employees are authorized reimbursement in the following manner for expenses incurred while performing official duties:

1. Reimbursement shall be made in accordance with the most current Louisiana Travel Guide available for reference at www.state.la.us/osp/traveloffice.htm.
2. Where circumstances require the approval of the Commissioner of the Division of Administration:

- a. Legislative officials and employees shall obtain the approval of the Council Chair.
 - b. Members and employees of Parish Boards, Commissions, and Special Districts shall obtain the approval of either the Parish President or the Parish Administrator.
 - c. Administrative officials and employees shall obtain the approval of either the Parish President or the Parish Administrator.
3. The following modifications are to be considered in application of the Travel Guide guidelines:
- 1. As Parish officials and employees are not to utilize state contracts for air transportation travel shall be made using commercial carriers service at the coach/economy class rates. The Parish does not require use of lowest priced airfare where circumstances which can be documented dictate otherwise.
 - 2. Travel out of the Parish or within the Parish that extends over 30 miles away from a persons domicile that extends through lunch will be reimbursed in accordance with the Traveler's Meal chart.
 - 3. The members of the Lafourche Parish Council and employees are authorized to receive a mileage allowance at the state approved rate for use of his personally owned vehicle in conduct of official Parish business.

Public information requests shall be honored in the most expeditious manner balancing the cost to the citizen with the schedule and knowledge of the parish employees. The effected Department Head shall determine how many and which employees will be used to gather and reproduce the information and whether overtime is necessary to accomplish the request. When overtime is necessary, this cost shall be borne by the citizen requesting the information plus the 1.5 multiplier. (Ord. No. 3771, 3/28/06)

SECTION 2:250. PARISH EMPLOYEES; HOLIDAYS DESIGNATED

A. The employees of the Lafourche Parish Council are hereby granted the following paid holidays:
New Years Day, the day before or after New Year's Day, Martin Luther King Day, the day before Mardi Gras, Mardi Gras, Good Friday, Memorial Day, Independence Day, Labor Day, Federal Elections Day, Thanksgiving Day, the day after Thanksgiving Day, Christmas Day, and either the day before or day after Christmas*

*Day to be selected annually by the Parish President

B. When a holiday falls on a weekend. The Appointing Authority may designate either the preceding Friday or following Monday as the holiday.

C. Parish employees may be given holidays on other days declared as state holidays by the Governor of the State of Louisiana.

Comment -- Ordinances No. 1350, 1741 and 1782 revised and added to the schedule of holidays for parish employees. Ord. No. 1782 added five days: Washington's Birthday, Good Friday, Memorial Day, All Saints Day and Veterans Day. It also added the language in Paragraph C stating that parish employees would also be given additional days declared as state holidays by the governor.

Ordinance No. 1339 superseded several earlier enactments dealing with holidays, including a Resolution of June 3, 1968, and Ordinances No. 894 (February 18, 1956 and 919 (February 13, 1957).

SECTION 2:251. SATURDAY ESTABLISHED AS LEGAL HOLIDAY

Pursuant to the authority vested in this body by LRS 1:55(2), the whole of every Saturday is hereby declared to be a holiday for all banks and savings and loan associations within the Parish of Lafourche, Louisiana. (Ord. No. 1379, 12/9/81)

SECTION 2:252. MARTIN LUTHER KING DAY ESTABLISHED AS A LEGAL HOLIDAY

A. The third Monday of each January beginning with 1993 shall be designated as "Martin Luther King, Jr. Day" in the Parish of Lafourche. (Ord. No. 2025, 4/8/92)

SECTION 2:253. COMPENSATORY LEAVE POLICY

A. Policy Statement.

1. It is the policy of Lafourche Parish Government to allow employees to earn Compensatory Leave for time worked above their normal schedule in a work week. Compensatory leave is leave time earned in lieu of cash payment at the straight-time or time and one-half as compensation for overtime worked.

2. The policy objective to ensure that Lafourche Parish Government employees who work overtime are adequately and properly compensated, as provided in the Fair Labor Standards Acts.

3. This policy applies to all Lafourche Parish Government employees.

B. Procedure for earning Compensatory Leave

1. Employees in positions that are designated as "Non-Exempt" are eligible to earn compensatory leave on an hour for hour basis for hours worked over 35 hours and up to 40 hours in a work week. Non-exempt employees who work over 40 hours in a work week will earn compensatory time at a rate of one and one-half hours for every overtime hour worked.

2. Employees in positions that are designated as "Exempt" earn compensatory time for any hours worked above their normal work schedule in a work week.

§ 2:253

3. No compensatory leave/overtime shall be worked by any Lafourche Parish Government employee with out prior approval of his or her supervisor.

4. Any overtime worked will be reported on the time sheet in the pay period in which it was earned. Employees are responsible for timely submission of overtime hours worked. Written approval by an employee's supervisor must accompany any request for earned compensatory time.

5. Annual and sick leave taken, whether with or without pay, shall not be counted as hours worked for purposes of determining overtime compensation for "non-exempt" employees.

6. Employees and their supervisors are to minimize the accumulation of compensatory leave. Lafourche Parish Government employees are limited to the accumulation of only 40 hours of compensatory leave.

C. Exceptions:

1. Hours worked during a declared emergency will be compensated in dollars in accordance with the Lafourche Parish Civil Service Guide.

2. Exempt and non-exempt employees will automatically participate in the compensatory leave program in lieu of receiving overtime wages unless they obtain prior written exception from their immediate supervisor. Supervisors must consider the need, budget considerations, and the ability of employees to use compensatory time.

3. Public Works field office employees will be automatically exempt from participation in the compensatory leave program, however, they may opt into the program with prior written supervisor approval.

D. Use of Compensatory Leave

1. Supervisors are to ensure that employee leave slips are marked with the appropriate leave category, according to the employee's leave balances

E. Disposition of Compensatory Leave

1. The Appointing Authority may require employees to take all or part of accrued compensatory leave at any time.

2. Upon separation or termination from Lafourche Parish Government, unused compensatory leave earned by non-exempt employees shall be paid at the employee's regular pay rate.

3. Upon separation or termination from Lafourche Parish Government, all unused compensatory leave earned by exempt employees shall be canceled.

4. Compensatory hours earned by exempt employees in excess of 40 must be used within the pay period earned (flexed) or they are lost.

5. Compensatory hours earned by non-exempt employees in excess of 40 hours will be compensated in wages. Prior written approval for non-exempt employees must include notice that compensation will be in excess of 40 hours.

SECTION 2:254. EMERGENCY PAY POLICY FOR LAFOURCHE PARISH EMPLOYEES

A. During severe weather or other emergency situations, the Administration shall have the sole authority to excuse employees of the Lafourche Parish Government from reporting to work. "Emergency Situation" shall encompass circumstances that would expose parish employees to harmful or unsafe conditions, as determined by the Administration.

B. The Administration may provide parish employees with "leave with pay" for absences from work due to a Declared State of Emergency. The Administration will issue a Declaration of Emergency stating that, because of extreme weather or other specified emergency situations, employees shall not report to work except at the request or approval of the Administration. Unless a Declaration of Emergency has been issued, all parish employees are expected to report to work. If the Administration officially directs the closure of the agency due to severe weather or other emergency situations, those persons actually scheduled to work or available for duty (on standby during the time period of the declaration shall receive the time off without loss of pay, annual leave, or sick leave. For the duration of the declaration of emergency, employees shall not be required to be on duty for more than 18 hours at a time or in a 24 hours period. All personnel, including both nonexempt and exempt classifications but excluding department heads and the parish administrator, who are required to be on emergency duty during such closure shall receive pay at the rate of double time for those actual hours. Furthermore, upon the declaration of an emergency, all scheduled vacations for designated essential personnel shall be cancelled.

C. During a Declaration of Emergency, all essential personnel shall be available for duty and necessary services will be maintained. The Administration, in conjunction with all Department Heads, will identify essential employees by position or title and will post a list thereof.

D. No provision of this Emergency Pay policy will preclude the necessary, immediate evacuation of a facility by an authorized supervisor in the interest of personal safety.

E. Transitional Provisions: In order to correct, ratify and authorize policies carried out and payments made during the 2005 Hurricane Season by the Administration, the Council shall hereby ratify the payment of overtime at the rate of double time and one half to both exempt and non-exempt unclassified parish employees. Overtime payments made to Department Heads and the Parish Administrator shall be excepted from this ratification. This ratification shall extend only to overtime payments made to those employees not excepted and only to overtime payments made during the 2005 Hurricane Season.

Part II — By-Laws and Standard Operating Procedures of the Parish Council

SECTION 2:300. BY LAWS AND OPERATING PROCEDURES OF THE PARISH COUNCIL; IN GENERAL

A. These provisions are intended to be in addition to existing statutes and laws of the State of Louisiana pertaining to the operations of parish governing authorities. Any specific provisions herein found to be in violation of state laws or statutes is hereby declared null and void. This, however, does not affect the validity of all other provisions.

§ 2:300

B. The provisions herein will supersede and replace all previous ordinances or resolutions of the Parish Council concerning the specific matters herein contained.

C. *Robert's Rules of Order* shall apply in the absence of clarification by these by-laws.

SECTION 2:301. BY LAWS AND OPERATING PROCEDURES OF THE PARISH COUNCIL

A. *Agenda* - A written agenda will be followed for all regular and special meetings. Any change in the Order of Business must receive a two-thirds vote of the members to be heard.

B. *Recording* - Regular and Special meetings will be tape recorded to aid the Council Clerk's Office in preparation of the minutes. All original tapes are to be kept with the Council Clerk's Office for use on the premises only. Copies of tapes are to be provided upon request.

C. *Minutes* - Results or actions taken will be prepared by the Council Clerk's Office and mailed to all Council members and the Administration with the agenda of the succeeding meeting.

D. *Voting Procedure* - A majority (5) of the members of the governing authority shall constitute a quorum. No action of the governing authority shall be valid or binding unless voted upon favorably by at least a majority of the members, except where a favorable two-thirds vote is required. Notwithstanding the foregoing, procedural or administrative matters may be adopted by a favorable vote of majority of the members present and voting.

E. *Agenda Items* -- Ordinances and Resolutions shall only be prescribed by a Council member. Upon receiving a super majority (7), any emergency item(s) may be considered at a Council meeting.

SECTION 2:302. BY-LAWS AND OPERATING PROCEDURE OF THE PARISH COUNCIL; BOARD APPOINTMENTS

A. All Parish board vacancies shall be advertised in the Official Journal of the Lafourche Parish Council and the Lafourche Gazette for a period of not less than two (2) weeks. All Council members deadline to submit an application shall coincide with the Council agenda deadline. If no resumes are received, the Council member(s) whose district falls within the boundaries of that respective board shall recommend an individual to fill the vacancy(ies). All applications received for a vacancy(ies) are to be submitted with the resolution in the agenda packet.

B. All appointments by the Lafourche Parish Council will be for a term of four (4) years unless otherwise provided by law.

SECTION 2:303. BY-LAWS AND OPERATING PROCEDURES OF THE PARISH COUNCIL; SPECIAL DISTRICTS AND PARISH AGENCIES

A. All Special districts and parish agencies under the jurisdiction of the Council, must submit written reports as follows:

1. Yearly - Budget.
2. All minutes of meetings.
3. All meeting agendas

B. All Special Districts and parish agencies under the jurisdiction of the Council, must submit yearly audits as indicated by State Statutes.

1. Two copies of the audit is required. One will be forwarded to the Finance Department by the Council Clerk's Office.

C. The Council Clerk's Office is to maintain all the above reports in special files.

1. The Council Clerk's Office is to create and maintain a receipt for each board as it submits required information.

2. The Finance Department will issue a receipt for each audit submitted by the Council Clerk's Office.

D. All boards and agencies of the Lafourche Parish Council shall submit to the Council Clerk's Office a written annual progress report which will contain their current operating budget and their accomplishments and activities. All boards and agencies of the Council with an annual operating budget in excess of \$50,000 shall also be required to give an oral presentation on accomplishments and activities on an annual basis. Any capital expenditures in excess of 25% of their annual budget shall be ratified by the Lafourche Parish Council. The Council can also request that any Parish board, regardless of the annual operating budget, present an oral report.

E. All budgets, agendas, and minutes shall be due in the Council Clerk's Office no later than January 31. Any report, written or oral, which is not received by the due date will be considered delinquent. As a result of being delinquent on these reports, the board members may be removed and the Lafourche Parish Council may assume the responsibilities of the board until a new board is appointed.

F. All audits (both copies) are due in the Council Clerk's Office no later than May 10th. If a board does not meet the above deadlines, all respective board members must attend the 2nd Council meeting in May to state their case why the deadline was not met. If members of the respective board(s) do not attend the 2nd May meeting, all board members will be removed.

G. All boards will be reminded of their due dates every January by the Council Clerk's Office. If the due date for all reports fall on a Saturday or Sunday, the report(s) must be turned in by the preceding Friday.

H. Any and all information received by any office other than the Council Clerk's Office is required to immediately forward said information to the Council Clerk's Office.

SECTION 2:304. COUNCIL STAFF

All clerical positions in the legislative department, excluding the Council Clerk and Internal Officer, are hereby created and designated as classified employees.

SECTION 2:305. BY-LAWS AND OPERATING PROCEDURES

A. All boards and commissions having members that serve at the pleasure of or that are appointed by the Lafourche Parish Council shall present all projects requiring applications for outside funding to the Lafourche Parish Council in the form of a Resolution for ratification by the Council. No application shall be submitted without prior approval of the Parish Council. This shall include but not be limited to all federal and state matching funds and grant programs

B. Non compliance of this ordinance will constitute termination.

SECTIONS 2:306 - 2:344. RESERVED

SECTION 2:345. THRESHOLD FOR SETTLEMENT OF LIABILITY AND WORKERS' COMPENSATION SETTLEMENTS

A. The Lafourche Parish Government does have the authority to review, approve, disapprove and/or pay for repairs, rentals, and in any other way mitigate damages with the consultation of the parish's third party claims administrator/adjuster on claims where they determine that the parish has liability and to settle other monetary claims on any type of liability settlement up to a threshold of five thousand (\$5,000.00) dollars.

B. The Administration together with the Third Party Administrator/Adjuster shall brief the Council in executive session at least quarterly on all claims and suits where specific approvals are not required and on all claims and suits covered by Worker's Compensation.

SECTION 2:350. PARISH PRESIDENT TO ADVISE COUNCIL OF DEVIATIONS IN PARISH REVENUES, EXPENDITURES, AND FUND BALANCES

A. The Parish President shall advise the Lafourche Parish Council in writing when:

1. Revenue collections plus projected revenue collections, within a fund are failing to meet estimated annual budgeted revenues by five percent (5%) or more.

2. Actual expenditures plus projected expenditures, within a fund are exceeding the estimated budgeted expenditures by five percent (5%) or more.

3. Actual beginning fund balance, within a fund, fails to meet estimated beginning fund balance by five percent (5%) or more of fund balance is being used to fund current year expenditures.

B. The written notification as required by this section as well as any responsive action taken by the governing authority shall be transmitted to and retained by the Parish President.

SECTION 2:351. PROCEDURES TO BE FOLLOWED BY PERSONS WISHING TO ADDRESS THE LAFOURCHE PARISH COUNCIL DURING ALL REGULAR AND SPECIAL MEETINGS

A. Any citizen wishing to address the Lafourche Parish Council on a particular matter for the purpose of discussion may place that matter on the meeting agenda by notifying the Council Clerk at least seven (7) calendar days prior to the meeting.

B. Any citizen addressing the Parish Council will be allowed a maximum of five (5) minutes to convey his/her concerns. In the event discussion by members of the Council ensues, the speaker will be allowed a maximum of two (2) minutes to rebut each Council question(s)/discussions.

C. No citizen shall be allowed to address the Lafourche Parish Council concerning the same matter at more than two (2) meetings.

D. Only one (1) citizen per meeting will be allowed to address the Council on an issue unless additional relevant information is presented.

E. Suspension from any provision of the policy can be made by a majority vote of members present at the meeting.

SECTION 2:352. USE OF PARISH-OWNED VEHICLES POLICY

A. It shall be the policy of Lafourche Parish Government that no vehicle owned by the parish government be driven by an employee of the parish government unless on business of such government. Any employee who is not on a twenty-four-hour-call basis shall not drive a parish-owned vehicles to and from work and his place of residence, whether such residence is temporary or permanent. A driver of a parish-owned vehicle shall be an employee, official or a member of the Parish Rapid Assessment Team of the parish government. A violation of this section shall be grounds for disciplinary action, as stated in the parish employee's manual, and/or termination of employment.

B. Any parish-owned vehicle deemed to be unused or unnecessary shall be declared surplus and advertised for public sale.

**SECTION 2:353. DEFINITION OF TERMS FOR USE IN CAPITAL OUTLAY
PROJECTS FOR THE ANNUAL LAFOURCHE PARISH
OPERATING AND CAPITAL BUDGETS**

A. The following policy and definitions in accordance with generally accepted accounting principles shall be used for budgetary purposes in the preparation and administration of the annual Operating and Capital Budgets:

1. Acquisition of Land – the acquisition of land shall always be considered a capital outlay regardless of the costs.

2. In the Five Year Capital Budget, Capital Outlay will be defined as any and all expenditures with an estimated price tag of over fifteen thousand dollars (\$15,000) that are required by ordinance and the Home Rule Charter to come before the Council for prior contract approval. In the Operating Budget, Capital Outlays will be defined as any and all expenditures that are valued over five thousand (\$5,000) and above that are to be depreciated.

B. It is the policy and preference to use parish employees, community service or voluntary labor when feasible for new construction, renovation, repair or maintenance of buildings, infrastructure or equipment. When this occurs as a part of a capital outlay project and contracts are not required to complete the project, the administration shall follow the public bid laws and the parish's requisition process and shall not be required to obtain supplementary council approval for individual purchases of material, parts and supplies necessary to complete capital outlay project.

Sub-Chapter D

**Organizational Structure of Local Agencies
and Certain Special Districts**

**SECTION 2:401. LOCAL AGENCIES, PROGRAMS AND CERTAIN
SPECIAL DISTRICTS**

In the governance of local agencies, programs and certain special districts, advisory committees or boards are formed to enhance the input from and involvement of the community. The existence of these 'committees or boards' create a unique partnership of public officials, public employees and private citizen performing a public service.

A. The following list of local agencies, programs and special districts shall follow the above listed structure.

1. The Community Action Agency as created as an agency of the Lafourche Parish Council at Chapter Twenty (20), SubChapter (A) shall be governed by this section under the Department of Community Services. In accordance with state and federal guidelines, the position of program manager shall be referred to as the Executive Director;

2. The Head Start Program as created as an agency of the Lafourche Parish Council at Chapter Twenty (20), Subchapter B shall be governed by this section under the Department of Community Services. In accordance with state and federal guidelines, the position of program manager shall be referred to as the Director and a vacancy in this position filled via a recommendation of the Head Start Policy Council;

3. The Coastal Zone Program as created under the Lafourche Parish Council at Chapter Nineteen, SubChapter F shall be governed by this section under the Department of Coastal, Energy and Environment;

B. When the created organization or program includes a board with advisory capacity the following structure shall be applied with regard to Powers and Duties:

1. The Parish Council shall have the following powers and duties:

a. To ratify appoints made by the Administration and/or recommended by the Advisory Board for the position of Program Manager of local agencies and programs;

b. To appoint members of the Board and Committee when provided by ordinance or by federal or state regulations after advertising and soliciting recommendations from the Advisory Board or Committee;

c. To approve annual budgets in accordance with the Home Rule Charter;

d. To ratify any and all bylaws and programmatic rules and procedures specific to said programs.

§ 2:401

2. The Administration shall have the following powers and duties:

a. To utilize its human resource department to advertise and coordinate interviews in the search of a program manager for use by the administration and/or the Advisory Board or Committee;

b. To appoint the program manager after soliciting the recommendation of the Advisory Board or Committee (except where provided otherwise);

c. To supervise the Program staff including the program manager consistent with and under the guide of the parish's administrative and personnel policies. These shall include the authority to discipline and dismiss any and all employees for cause;

d. To oversee the finances of the program or district including any and all public revenue sources in compliance with and under the guide of the parish's fiscal policies. These shall include purchasing, accounting and audit functions and the parish's finance director shall serve as Treasurer unless provisions are detailed otherwise;

e. To sign on behalf of the Lafourche Parish Government on grant applications, contract and grant documentation for continuing and newly approved programs, amendments and reports overseeing and providing necessary assurances of compliance with conditions related to program grants and contracts;

3. The Advisory Board, Committee and/or Special District Board shall have the following powers and duties:

a. To select its own officers, and as provided within bylaws select representatives of the board, commission, committee and/or special district;

b. To make recommendations to fill vacancies on the board commission, committee, special district and/or programs manager where provided by federal or state guidelines;

c. To assist the program manager in developing new programs and evaluating and improving existing services in the community;

d. To make recommendations to the parish council, the administration and to the program manager in relevant decisions regarding program matters;

e. To participate in the development of the program's operating budget;

f. To formalize the creation of special or sub-committees ensuring compliance with open meeting laws, maintaining minutes, notifying the parish council and justifying their creation.

4. The Program Manager shall have the following powers and duties:

a. To supervise his/her staff in accordance with the parish's personnel guidelines and under the direction of the Administration and the assigned Department;

b. To administer programs in accordance with provisions of applicable grants, contracts, parish fiscal and administrative policy, programmatic rules and procedure, and applicable federal and state law;

- c. To coordinate Board and/or Committee Meetings.
- d. To provide a report to the Parish Council at least quarterly including a written report submitted to the Council Clerk for submission with the meeting agenda;
- e. To provide an annual presentation to the council of the program year;
- f. To be available at appropriate council meetings to answer any questions regarding quarterly and annual reports.

C. Transitional Language – Each of the local agencies, programs and special districts listed in Part B are required to review its bylaws and programs documentation for consistency with the structure outline in Part A above. The responsible Board or Committee shall recommend and approve amendments in their bylaws and program documentation within 60 days to accommodate these changes.

SECTION 2:402. BOARD, AGENCIES AND NONPROFITS REQUIRED TO SUBMIT CURRENT AUDITED FINANCIAL REPORTS

A. Any board, agency, or non-profit organization that requests any funds from the parish must provide the Council with a copy of their current audited financials prior to the parish transferring the funds. All funds used by these non-profit organizations must be dedicated to certain projects, and those organizations must come before the Council every six (6) months with a progress report.

B. The Lafourche Parish Finance Department shall review the audited financials submitted by the board, agency, or non-profit organization and give a report to the Council on their findings prior to the parish transferring the funds.

SECTIN 2:403. BOARD, AGENCY AND COMMITTEE MEETINGS NOT TO CONFLICT WITH COUNCIL MEETINGS

No Lafourche Parish board or agency shall hold their Board or Committee meetings in conflict with the regularly scheduled Lafourche Parish Council meetings in order to allow Parish Council Members and representatives of the Administration the opportunity to attend the meetings.
