

**THIS ORDINANCE WAS RESCINDED (BY ORDINANCE NO. 3726)**  
**AT THE JANUARY 10, 2006 LAFOURCHE PARISH COUNCIL MEETING.**

The following ordinance was introduced by Mr. Brent Callais in regular session convened on April 12, 2005.

PROPOSED ORDINANCE

The following ordinance, having been previously introduced and published, was offered for final adoption by Mr. Brent Callais, seconded by Mr. Mark Atzenhoffer.

**ORDINANCE NO. 3614**

**AN ORDINANCE APPROVING AND AUTHORIZING THE PURCHASE OF PROPERTY FROM SACRED HEART CATHOLIC CHURCH IN CUT OFF LOCATED BETWEEN THE CUT OFF YOUTH CENTER AND LOUISIANA HIGHWAY 3235 IN ORDER TO CONSTRUCT A COMMUNITY PARK, INCLUDING A WALKING TRAIL FOR PUBLIC USE; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER SAID PURCHASE.**

**BE IT ORDAINED**, by the Lafourche Parish Council, convened in Regular Session on June 14, 2005, that:

**SECTION 1.**

**WHEREAS**, as a part of the Lafourche On the Move Program, the administration is seeking sights for the construction of a community park, including a walking trail in Lafourche Parish; and

**WHEREAS**, the Sacred Heart Catholic Church of Cut Off wishes to sell a certain tract of land located between the Cut Off Youth Center and Louisiana Highway 3235 (property description to be attached); and

**WHEREAS**, Lafourche Parish Government wishes to buy said property for Forty Three Thousand Nine Hundred dollars and no/100 (\$43,900);

**THEREFORE BE IT ORDAINED**, that the Lafourche Parish Council does approve and authorize the purchase of said property (See attached property description) from Sacred Heart Catholic Church of Cut Off; and authorizes the Parish President to sign, execute and administer said purchase, upon approval of the Planning Commission.

**SECTION 2.** If any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not effect other provisions, items or application of this ordinance which can be given affect without the invalid provisions, items or application, and to this end the provisions of this ordinance are declared severable.

**SECTION 3.** All Ordinance or parts of Ordinances by the Lafourche Parish Council conflicting with or inconsistent with the provisions of these regulations are hereby repealed.

**SECTION 4.** This Ordinance shall be published in the Official Journal of the Lafourche Parish Council in the manner provided by law.

**SECTION 5.** This Ordinance, having been submitted in writing, having been read and adopted by sections at a public meeting of said council, was then submitted to an official vote as a whole, the vote thereon being as follows:
