**RESOLUTION NO. 09-042**

**RESOLUTION IN SUPPORT OF A GRANT PRE-APPLICATION BY LAFOURCHE PARISH GOVERNMENT WITH THE DELTA REGIONAL AUTHORITY.**

**WHEREAS**, the purpose of the Delta Regional Authority (DRA) is to assist units of local governments with funding for basic public infrastructure in distressed counties, transportation infrastructure for the purpose of facilitating economic development, business development with an emphasis on entrepreneurship and job training with an emphasis on using existing public education institutions; and

**WHEREAS**, Delta Regional Authority works closely with local development district, which provide technical assistance to grant applicants and in our region, that local development district is South Central Planning & Development Commission; and

**WHEREAS**, per the guidelines and eligibility of projects which meet the Delta Regional Authority program, Lafourche Parish Government has identified the water lines and paved parking lot of the Central Market project to be located at the Highway 90/Highway 1 interchange next to the Lafourche Parish Tourist Commission Office as a possible project for this funding opportunity; and

**WHEREAS**, Lafourche Parish Government, through South Central Planning & Development Commission, will be submitting a grant pre-application to the Delta Regional Authority for funding of the water lines and paved parking lot for the Central Market project to be located at the Highway 90/Highway 1 interchange next to the Lafourche Parish Tourist Commission Office; and

**WHEREAS**, the grant guidelines have a deadline to submit pre-applications in March, 2009 and the guidelines require a resolution from the local governing authority to be submitted with the pre-application forms; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council support this grant pre-application.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on January 27, 2009, and does hereby support the grant application of the Lafourche Parish Government with the Delta Regional Authority for the water lines and paved parking lot for the Central Market project to be located at the Highway 90/Highway 1 interchange next to the Lafourche Parish Tourist Commission Office.

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution shall be forwarded to the Grants & Economic Development Office; and the Office of the Parish Administrator.
