

On motion by Daniel Lorraine, and seconded by Rodney Doucet, the following resolution was introduced and adopted:

RESOLUTION NO. 09-046

RESOLUTION REQUESTING THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT (LADOTD) CONSIDER INSTALLING WARNING CAUTION LIGHTS AT THE INTERSECTION OF LA 1 SOUTH GOLDEN MEADOW TO ALEX PLAISANCE BOULEVARD, 3161 IN CUT OFF, LA TO LA 3235, 657 IN LAROSE, LA TO 3235, AND WHERE 3235 INTERSECTS TO LA 24 BOURG-LAROSE; ALSO INSTALL FLASHING LIGHTS HEADING SOUTH AT 3162 (GALLIANO RED LIGHT) AND HEADING NORTH AT 3162 (GALLIANO RED LIGHT) LOCATED ON 3235; ALSO TO REVIEW THE SPEED LIMIT TO SEE IF IT CAN BE CHANGED TO ALL THE SAME SPEED LIMIT FROM NORTH OF GOLDEN MEADOW TO THE INTERSECTION OF LA 24.

WHEREAS, many accidents and fatalities have occurred in this area; and

WHEREAS, school zones connect to 3235, subdivision streets connect to 3235 and a large section of LA 3235 is industrial populated; and

WHEREAS, the Lafourche Parish Council has made and continues to make requests to the Louisiana Department of Transportation and Development which concerns the general health, safety and welfare of the citizens of the Parish; and

WHEREAS, it is the duty upon oath that the Governing Authority and State Officials address concerns dealing with the general health, safety and welfare of the citizens and said resolution satisfies this criteria; and

BE IT RESOLVED, by the Lafourche Parish Council convened in regular session on February 10, 2009, that it does hereby request the Louisiana Department of Transportation and Development (LADOTD) consider installing warning caution lights at the intersection of LA 1 South Golden Meadow to Alex Plaisance Boulevard, 3161 in Cut Off, LA to LA 3235, 657 in Larose, LA to 3235, and where 3235 intersects to LA 24 Bourg-Larose; also install flashing lights heading south at 3162 (Galliano Red Light) and heading north at 3162 (Galliano Red Light) located on 3235; also to review the speed limit to see if it can be changed to all the same speed limit from north of Golden Meadow to the intersection of LA 24.

BE IT FURTHER RESOLVED, that a certified copy of this resolution be forwarded to the Louisiana Department of Transportation and Development, Attn: Mr. John Evanco, Post Office Box 94245, Baton Rouge, Louisiana 70804-9245; Legislative Delegation of Lafourche and Terrebonne Parishes; State Senate President Joel Chaisson; Speaker of the House Jim Tucker; and the Office of the Parish Administrator.
