

On motion by Rodney Doucet, seconded by Lindel Toups, the following resolution was introduced and adopted;

RESOLUTION NO. 09-058

A RESOLUTION ACCEPTING THE LOW BID OF LA CONTRACTING ENTERPRISE, LLC IN THE AMOUNT OF FORTY-FOUR THOUSAND NINE HUNDRED NINETY-FIVE DOLLARS (\$44,995.00) FOR CONSTRUCTION OF A WALKING TRACK IN CUT OFF AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ANY AND ALL ASSOCIATED DOCUMENTS.

WHEREAS, playground equipment had already been acquired by the Cut Off Youth Center through a grant from the Gheens Foundation; and

WHEREAS, the Parish previously purchased land adjacent to the Cut Off Youth Center as a prime location for constructing a walking track; and

WHEREAS, five (5) bids were received and read publicly on January 15, 2009 as follows:

Picciola Construction Co.	\$51,900.00
HHP Construction Group	\$47,422.00
Carpenter's Services, Inc.	\$46,800.00
LA Contracting Enterprise	\$44,995.00

WHEREAS, a resolution was included on the February 10, 2009 agenda to de-dedicate the balance of the \$17,647.00 from the 2005 "Walking Trails/Pavilions" project to this project due to it coming in over budget; and

WHEREAS, it is the recommendation of John Plaisance, of J. Wayne Plaisance, Inc. (project engineer) that the bid of LA Contracting Enterprise, LLC be accepted; and

WHEREAS, this resolution was sponsored for Administration by Mr. Rodney Doucet, Councilman, District 8; and

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on February 10, 2009, and does hereby accept the bid of forty-four thousand nine hundred ninety-five dollars (\$44,995.00) by LA Contracting Enterprise, LLC; and authorizes the Parish President to sign, execute, and administer all related documents.
