

On motion by Joe Fertitta, and seconded by Phillip Gouaux, the following resolution was introduced and adopted:

RESOLUTION NO. 09-067

RESOLUTION REQUESTING THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT (LADOTD) CONSIDER REDUCING THE SPEED LIMIT TO FIFTY (50) MILES PER HOUR ON LOUISIANA HIGHWAY 1 AND ALSO CONSIDER INSTALLING GUARD RAILS ON LOUISIANA HIGHWAY 1, 3/10THS OF A MILE SOUTH OF LAFOURCHE CROSSING ON THE LEFT HAND SIDE OF THE ROAD WHERE THE TWO (2) TRAILERS WHOSE ADDRESSES ARE KNOWN AS 1325 HIGHWAY 1 AND 1327 HIGHWAY 1 ARE LOCATED DOWN FROM THE HIGHWAY ON THE BATTURE.

WHEREAS, many accidents and fatalities have occurred in this area; and

WHEREAS, the Lafourche Parish Council has made and continues to make requests to the Louisiana Department of Transportation and Development which concerns the general health, safety and welfare of the citizens of the Parish; and

WHEREAS, it is the duty upon oath that the Governing Authority and State Officials address concerns dealing with the general health, safety and welfare of the citizens and said resolution satisfies this criteria; and

BE IT RESOLVED, by the Lafourche Parish Council convened in regular session on March 10, 2009 that it does hereby request the Louisiana Department of Transportation and Development (LADOTD) consider reducing the speed limit to fifty (50) miles per hour on Louisiana Highway 1 and also consider installing guard rails on Louisiana Highway 1, 3/10th of a mile south of Lafourche Crossing on the left hand side of the road where the two (2) trailers whose addresses are known as 1325 Highway 1 and 1327 Highway 1 are located down from the highway on the batture.

BE IT FURTHER RESOLVED, that a certified copy of this resolution be forwarded to the Louisiana Department of Transportation and Development, Attn: Mr. John Evanco, Post Office Box 94245, Baton Rouge, Louisiana 70804-9245; Legislative Delegation of Lafourche Parish; and the Office of the Parish Administrator.
