**RESOLUTION NO. 09-069**

**RESOLUTION AGAIN REQUESTING GOVERNOR BOBBY JINDAL TO MOVE ON HIS RATIFICATION OF HIS APPOINTMENT TO THE NORTH LAFOURCHE LEVEE, CONSERVATION AND DRAINAGE DISTRICT DUE TO RESIDENTS ON HIGHWAY 308 SIDE OF BAYOU LAFOURCHE NOT BEING REPRESENTED BY PEOPLE RESIDING IN THEIR DISTRICT.**

**WHEREAS**, it is the duty upon oath that the Governing Authority and State Officials address concerns dealing with the general health, safety and welfare of the citizens, and said resolution satisfies this criteria; therefore

**BE IT RESOLVED**, by the Lafourche Parish Council convened in regular session on March 10, 2009, that it does hereby request Governor Bobby Jindal to move on his ratification of his appointment to the North Lafourche Levee, Conservation and Drainage District due to residents on Highway 308 side of Bayou Lafourche not being represented by people residing in their District.

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution be forwarded to the Office of Louisiana Governor Bobby Jindal; North Lafourche Levee, Conservation and Drainage District; Baton Rouge Delegation and the Office of the Parish Administrator.
