

On motion by Daniel Lorraine, seconded by Rodney Doucet, the following resolution was introduced and adopted;

RESOLUTION NO. 09-070

RESOLUTION APPOINTING TWO (2) COMMISSIONERS TO THE VETERANS' MEMORIAL DISTRICT OF WARD 10 OF LAFOURCHE PARISH BOARD.

WHEREAS, Mr. Clyde Orgeron and Mr. Vincent Doucet served on the Veterans' Memorial District of Ward 10 of Lafourche Parish Board representing the Delvin Adams American Legion Post 315; and

WHEREAS, according to Lafourche Parish Government's records, Mr. Clyde Orgeron and Mr. Vincent Doucet had terms which expired; and

WHEREAS, according to State law which created the Veterans' Memorial District of Ward 10 of Lafourche Parish, the Delvin Adams American Legion Post 315 in Galliano shall submit four (4) names and the council shall select and appoint two (2) members from the list submitted by each post; and

WHEREAS, the Delvin Adams American Legion Post 315 in Galliano recommends Patrick Picou, Irwin Bouvier, Vincent Doucet or Clyde Orgeron be appointed to represent the Delvin Adams American Legion Post 315 on the Veterans' Memorial District of Ward 10 of Lafourche Parish Board and fill the two vacancies; and

WHEREAS, due to health issues, Mr. Irwin Bouvier has recently notified this office that he will not be able to serve; and

WHEREAS, this resolution was sponsored for Administration by Mr. Daniel Lorraine, District 9; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this recommendation.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on March 10, 2009, and does hereby appoint Vincent Doucet and Clyde Orgeron to each serve a three (3) year term beginning March 10, 2009 and ending March 9, 2012 to the Veterans' Memorial District of Ward 10 Board of Lafourche Parish Board.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to Vincent Doucet and Clyde Orgeron; Veterans' Memorial District of Ward 10 of Lafourche Parish Board, Attention: Linton Doucet, 154 Dursette Street, Golden Meadow, LA 70357; and the Office of Grants and Economic Development.
