**RESOLUTION NO. 09-071**

**RESOLUTION APPOINTING TWO (2) COMMISSIONERS TO THE VETERANS' MEMORIAL DISTRICT OF WARD 10 OF LAFOURCHE PARISH BOARD.**

**WHEREAS**, Mr. George St. Pierre and Mr. Charles Roy Breaux served on the Veterans' Memorial District of Ward 10 of Lafourche Parish Board representing the Gros Guidry VFW Post 8538; and

**WHEREAS**, according to the Lafourche Parish Government's records, Mr. George St. Pierre and Mr. Charles Roy Breaux had terms which expired; and

**WHEREAS**, according to State law which created the Veterans' Memorial District of Ward 10 of Lafourche Parish, the Gros Guidry VFW Post 8538 in Larose shall submit four (4) names and the Council shall select and appoint two (2) members from the list submitted by each post; and

**WHEREAS**, the Gros Guidry VFW Post 8538 recommends Larry Raymond, John Turchim, George St. Pierre or Clarence Cheramie, be appointed to represent the Gros Guidry VFW Post 8538 on the Veterans' Memorial District of Ward 10 of Lafourche Parish Board and fill the two (2) vacancies; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Daniel Lorraine, District 9; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this recommendation.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on March 10, 2009, and does hereby appoint Larry Raymond and George St. Pierre to each serve a three (3) year term beginning March 10, 2009 and ending March 9, 2012 to the Veterans' Memorial District of Ward 10 of Lafourche Parish Board.

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution shall be forwarded Larry Raymond and George St. Pierre; Veterans' Memorial District of Ward 10 of Lafourche Parish Board, Attention: Linton Doucet, 154 Dursette St., Golden Meadow, LA 70357; and the Office of Grants and Economic Development.
