**RESOLUTION NO. 09-072**

**RESOLUTION APPOINTING THREE (3) MEMBERS TO THE LAFOURCHE PARISH YOUTH COUNCIL.**

**WHEREAS**, the young people of Lafourche Parish are very important to the future of this Parish; and

**WHEREAS**, Ordinance 3547 created the Lafourche Parish Youth Council and assigned with the task of recommending to any Elected Officials, Governing Subdivisions, Boards, Commissions and Committees, of what is best and in the best interest of the youth of this Parish, State, Nation and World; and

**WHEREAS**, said Ordinance allows each Lafourche Parish Council Member to appoint one (1) person to sit as a member on the Lafourche Parish Youth Council from their respective Councilmatic District who must live in that Councilmatic District during their service time; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this application

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on March 10, 2009, that it does hereby appoint Kristen Legendre as the Councilmatic District 2 Representative; Andrea Foote as the Councilmatic District 3 Representative and Jovi Cheramie as the Councilmatic District 9 Representative to the Lafourche Parish Youth Council, to serve at the Pleasure of the Council.
