

On motion by Michael Delatte, seconded by Joe Fertitta, the following resolution was introduced and adopted;

**RESOLUTION NO. 09-074**

**RESOLUTION APPOINTING THREE (3) COMMISSIONERS TO THE LAFOURCHE PARISH HEROES MONUMENT COMMISSION.**

**WHEREAS**, Ordinance No. 4360, adopted at the August 12, 2008 meeting of the Lafourche Parish Council, created the Lafourche Parish Heroes Monument Commission; and

**WHEREAS**, the board is comprised of nine (9) members, all which shall be electors domiciled outside of Ward 10; five (5) of which shall be Honorably Discharged Veterans of a Branch of the U. S. Armed Forces; two (2) members shall have been employed as a Commission Police Officer for a minimum of five years; and two (2) members shall have served as a fireman for a minimum of five years; and

**WHEREAS**, three (3) appointments were made for the Honorably Discharged Veterans on this board by the council at its December 9, 2008 meeting, that being Mr. Forrest Travirca, III, Mr. Leroy Chenier and Mr. David Aucoin; and

**WHEREAS**, Mr. David Aucoin was appointed and passed away and there are three (3) vacancies for the Honorably Discharged Veterans on this board; and

**WHEREAS**, these positions were advertised and Thomas Tabor, Eddie Tabor, Robert Harris and Kevin Braud, submitted applications to fill three (3) positions for Honorably Discharged Veterans of a Branch of the U. S. Armed Forces; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Michael Delatte, District 2; and,

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on these vacancies.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on March 10, 2009, and does hereby appoint to the Lafourche Parish Heroes Monument Commission: Mr. Thomas Tabor, to serve an initial three (3) year term beginning March 10, 2009 and ending March 9, 2012; Mr. Eddie Tabor, to serve an initial four (4) year term beginning March 10, 2009 and ending March 9, 2013; Mr. Robert Harris, to serve an initial four (4) year term beginning March 10, 2009 and ending March 9, 2013.

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution shall be forwarded to Thomas Tabor, 159 Coteau Lane, Thibodaux, Louisiana 70301, Eddie Tabor, 1206 Lafourche Drive, Thibodaux, Louisiana 70301 and Robert Harris, 102 Marcello Blvd., Thibodaux, Louisiana and the Office of Grants and Economic Development.
