RESOLUTION APPOINTING THREE (3) COMMISSIONERS ON THE FIFTH WARD GRAVITY DRAINAGE DISTRICT NO. 5 BOARD.

WHEREAS, Mr. Raoul Bourgeois Jr., Mr. John Peltier and Mr. Wade Knight serve on the Fifth Ward Gravity Drainage District No. 5 Board; and

WHEREAS, according to the Lafourche Parish Government's records, Mr. Raoul Bourgeois, Jr.'s term expired on December 19, 1987, Mr. John Peltier's term expired on January 1, 2007 and Mr. Wade Knight's term expired on January 28, 1992; and

WHEREAS, these positions were advertised and three (3) applications were received; and

WHEREAS, Mr. Raoul Bourgeois, Jr., Mr. John Peltier and Mr. Todd Soignet submitted their applications to fill these positions; and

WHEREAS, this resolution was sponsored for Administration by Mr. Louis Richard, District 3; and

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on March 10, 2009, and does hereby appoint/reappoint Mr. Raoul Bourgeois, Jr., Mr. John Peltier and Mr. Todd Soignet to the Fifth Ward Gravity Drainage District No. 5 Board to serve a five (5) year term beginning March 10, 2009 and ending March 9, 2014.
