**RESOLUTION NO. 09-080**

**RESOLUTION APPROVING THE PURCHASE OF THREE (3) JOHN DEERE TRACTORS WITH TWO (2) TIGER ROTARY BOOM MOWERS, AND ONE (1) TIGER SIDE & REAR ROTARY MOWER FOR THE DEPARTMENT OF PUBLIC WORKS AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ALL RELEVANT DOCUMENTS.**

**WHEREAS**, Galliano and Bayou Blue Field Offices are in need of a tractor to be able to maintain grass along the road side ditches and outfall canals throughout the Parish; and

**WHEREAS**, this equipment will be used throughout the Parish; and

**WHEREAS**, the following will be purchased through State Contract:

(3) John Deere 6430 Tractors from Sunshine Equipment   \$ 41,862.88 each  
Total: \$ 125,588.64

(2) Tiger Rotary Boom Mowers from Covington Sales and Service \$ 35,160.45 each  
Total: \$ 70,320.90

(1) Tiger Side & Rear Rotary Mower from Covington Sales and Services  
\$ 38,657.40 each

**TOTAL** **\$ 234,566.94**

**WHEREAS**, all funds have been allocated within the Drainage Funds in the 2009 Operating Budget; and

**WHEREAS**, this resolution is sponsored for Administration by Mr. Phillip Gouaux, Councilman, District 7; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approves said purchase of three (3) John Deere Tractors, two (2) Tiger Rotary Boom Mowers, and one (1) Tiger Side & Rear Rotary Mower for a total of \$ 234,566.94 and authorizes the Parish President to sign, execute, and administer any and all relevant documents.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on March 10, 2009, and does hereby authorize the purchase of three (3) John Deere Tractors, two (2) Tiger Rotary Boom Mowers, and one (1) Tiger Side & Rear Rotary Mower for a total of \$ 234,566.94 and authorizes the Parish President to sign, execute, and administer any and all relevant documents.
