**RESOLUTION APPROVING A NINE (9') RAIL CAR FOR THE RITA BRIDGE LOCATED IN LOCKPORT, LOUISIANA AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, a rail car is needed for the Rita Bridge; and

**WHEREAS**, the public bid law was followed by receiving three (3) quotes for the Rita Bridge Rail Car as follows:

**WHEREAS**, it is the recommendation of the Department of Public Works and Administration that the price quote of \$19,500.00, from Salem Pipe & Steal Co. be accepted; and

**WHEREAS**, this will be funded through the 2009 Capital Budget, BR009 - Rita Bridge Project; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approves the purchase of the rail car for Rita Bridge from Salem Pipe & Steal Co. for a total of \$19,500.00; and authorizing the Parish President to sign, execute, and administer any and all relevant documents.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on March 10, 2009, and does hereby approve the purchase of a rail car for Rita Bridge from Salem Pipe & Steal Co. for a total of \$19,500.00; and authorizes the Parish President to sign, execute, and administer any and all relevant documents.
