

On motion by Louis Richard, seconded by Michael Delatte, the following resolution was introduced and adopted;

RESOLUTION NO. 09-093

RESOLUTION APPROVING AN AGREEMENT FOR PROFESSIONAL SERVICES BETWEEN SIEMENS BUILDING TECHNOLOGIES, INC. AND LAFOURCHE PARISH GOVERNMENT TO PROVIDE FOR INSPECTIONS AND SERVICE TO THE FIRE ALARMS AND LIFE SAFETY DEVICES AND EQUIPMENT AT THE LAFOURCHE PARISH DETENTION CENTER FOR 2009 AND 2010; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID CONTRACT.

WHEREAS, Lafourche Parish Government recognizes the importance and necessity of fire alarms and life safety systems at the Lafourche Parish Detention Center; and

WHEREAS, Siemens Building Technologies, Inc. has provided quality service in maintaining these systems and records; and

WHEREAS, this contract, which will be effective until December 31, 2010, comes with an annual cost attached of \$1,213.00 in 2009 and \$1,250.00 in 2010 (both for inspections) and also sets labor costs on individual service requests; and

WHEREAS, this resolution was sponsored for Administration by Mr. Louis Richard, Councilman, District 3; and

WHEREAS, it is the recommendation of the Administration that Siemens Building Technologies, Inc. be hired to provide the needed services; and

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on March 10, 2009, and does hereby approve hiring Siemens Building Technologies to provide inspections and service to the fire alarms and life safety devices at the Lafourche Parish Detention Center; and authorizes the Parish President to sign, execute, and administer said contract.

BE IT FURTHER RESOLVED, that a certified copy of this Resolution shall be forwarded to Siemens Building Technologies, Inc. (c/o Lisa Blady, 104 Announce Street, Lafayette, LA 70507); Lafourche Parish Government Department of Parks, Recreation & Public Facilities, Finance Department, and the office of the Parish Administrator.
