

On motion by Joe Fertitta, seconded by Louis Richard, the following resolution was introduced and adopted;

**RESOLUTION NO. 09-110**

**REQUESTING THAT THE LAFOURCHE PARISH COUNCIL HIRE LEONARD CHAUVIN P.E., P.L.S., INC. TO CONDUCT A HYDRAULIC STUDY OF PARKSIDE DRIVE AND VICINITY, IN THIBODAUX, LOUISIANA; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID AGREEMENT AND ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, the residential area of Parkside Drive and vicinity, in the Thibodaux area, has had drainage problems; and

**WHEREAS**, the Lafourche Parish Council has funds to install a pump to assist the elimination of the possibility of future flooding, and

**WHEREAS**, an engineering hydraulic study is necessary for the purpose of pump placement and capacity, and

**WHEREAS**, Leonard Chauvin, P.E., P.L.S., Inc. has provided the attached proposal for said study; and

**WHEREAS**, this resolution is sponsored for Administration by Mr. Joe Fertitta, Councilman, District 4; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council authorize the Parish President to sign, execute, and administer said agreement and any and all relevant documents.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on March 24, 2009, and does hereby approve the hiring of Leonard Chauvin P.E., P.L.S., Inc. for the purposes of conducting a hydraulic study for Parkside Drive and vicinity and authorizing the Lafourche Parish President to sign, execute, and administer said agreement and any and all relevant documents.

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution shall be forwarded to Leonard Chauvin P.E., P.L.S., Inc. 627 Jackson Street, Thibodaux, LA 70301; Lafourche Parish Government Department of Public Works, and the Office of the Parish Administrator.
