**RESOLUTION NO. 09-113**

**RESOLUTION APPROVING A TIME EXTENSION TO ACQUIRE PROPER CABLE SPOOL FOR THE T-BOIS BRIDGE AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ALL RELEVANT DOCUMENTS.**

**WHEREAS**, Department of Public Works has no objection to a time extension to acquire proper cable spool for the T-Bois Bridge from Thirdcoast Electrical Services; and

**WHEREAS**, this item was not ordered wrong, there was an engineering change and the original ring assembly size is no longer available; and

**WHEREAS**, it is important to complete the work as soon as it is delivered; and

**WHEREAS**, this is for Item #14 under Option 1; this extension is justified and will benefit the Parish in that a brand new cable reel will be installed, a value of \$ 3,000.00, at no greater cost to the Parish; and

**WHEREAS**, Thirdcoast Electrical Services is requesting a 75 day extension with the completion date being June 4, 2009; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Phillip Gouaux, Councilman, District 7; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approves said time extension for the proper cable spool; and authorizes the Parish President to sign, execute, and administer any and all relevant documents.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on March 24, 2009, and does hereby authorize the time extension to acquire proper cable spool for the T-Bois Bridge and authorizes the Parish President to sign, execute, and administer any and all relevant documents.
