RESOLUTION APPOINTING ONE (1) COMMISSIONER TO REPRESENT THE LAFOURCHE PARISH CORONER'S OFFICE ON THE LAFOURCHE PARISH CHILDREN AND YOUTH PLANNING BOARD.

WHEREAS, Dr. Coleridge Franklin, serve on the Lafourche Parish Children and Youth Planning Board and represented the Lafourche Parish Coroner's Office on the Board; and

WHEREAS, according to the Lafourche Parish Government's records, Dr. Coleridge Franklin retired June, 2008; and

WHEREAS, in a letter from Lafourche Parish Coroner's office, Dr. John C. King, recommends Mr. Mark Goldman be appointed to the Lafourche Parish Children and Youth Planning Board; and
