RESOLUTION APPOINTING FOUR (4) COMMISSIONERS TO THE HOME MORTGAGE AUTHORITY.

WHEREAS, this resolution was sponsored for Administration by Mr. Joseph Fertitta, Councilman District 4; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on these applications.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on April 14, 2009, and does hereby reappoint Mr. Jeremiah St. Pierre, Mr. James Barnidge, Mr. Bruce McManis and Mr. Charles Maggio to the Home Mortgage Authority to serve a four (4) year term beginning April 14, 2009 and ending April 13, 2013.
