RESOLUTION NO. 09-134

RESOLUTION RATIFYING THE APPOINTMENT OF MRS. SHANNON CURLEY CHIASSON TO REPRESENT THE NICHOLLS STATE UNIVERSITY ALUMNI ON THE LAFOURCHE PARISH CIVIL SERVICE BOARD.

WHEREAS, Mr. Ronnie Lefort, the representative for the Nicholls State University Alumni, resigned as a member to the Lafourche Parish Civil Service Board; and

WHEREAS, according to Section 4 of Article IV of the Lafourche Parish Home Rule Charter, one (1) member shall be nominated by the Board of Directors of the Alumni Association of Nicholls State University, the selected nominee is then submitted to the President who shall thereafter submit the name to the Council for approval or rejection of the appointment; and

WHEREAS, appointments to said Board shall be for four (4) years; and

WHEREAS, in a letter dated March 23, 2009, the Nicholls State University Alumni Federation has nominated Mrs. Shannon Curley Chiasson to fill the vacancy on the Civil Service Board; and

WHEREAS, it is recommended by Parish President Charlotte Randolph that this be approved by Council; and

WHEREAS, this resolution was sponsored for Administration by Mr. Michael Delatte, Councilman, District 2; and

BE IT RESOLVED, by the Lafourche Parish Council convened in regular session on April 14, 2009, that it does hereby ratify the appointment of Mrs. Shannon Curley Chiasson to replace Mr. Ronnie Lefort as the Nicholls State University's representative on the Lafourche Parish Civil Service Board with her term to expire four (4) years from the adoption of said resolution.

BE IT FURTHER RESOLVED, that a certified copy of this resolution be forwarded to the Lafourche Parish Government Civil Service Department, and the Office of the Parish Administrator.
