

On motion by Lindel Toups, seconded by Phillip Gouaux, the following resolution was introduced and adopted:

RESOLUTION NO. 09-147

RESOLUTION APPROVING A COOPERATIVE ENDEAVOR AGREEMENT BETWEEN THE LAFOURCHE PARISH GOVERNMENT AND LAFOURCHE PARISH RECREATION DISTRICT #2 TO ARRANGE FOR THE FUNDING OF STORM REPAIRS; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID AGREEMENT(S) AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, the Raceland Recreation Center and surrounding grounds suffered damage during Hurricane Gustav; and

WHEREAS, the Recreation District is requesting funding from the Parish to help upfront with funding for these repairs; and

WHEREAS, the Recreation District is filing claims with FEMA to help reimburse funds spent on repairs; and

WHEREAS, this agreement ensures that the Recreation District will turn over to the Parish any money reimbursed by FEMA for said repairs; and

WHEREAS, this resolution was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on April 14 2009, and does hereby approve a Cooperative Endeavor Agreement between the Lafourche Parish Government and Lafourche Parish Recreation District #2 for the purpose of arranging for the loan and re-payment of funding to help with storm repairs; and authorizes the Parish President to sign, execute, and administer said agreement(s) and any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this Resolution shall be forwarded to Lafourche Parish Recreation District #2; Lafourche Parish Government Department of Parks, Recreation and Public Facilities; Department of Finance, and the Office of the Parish Administrator.
