

On motion by Michael Delatte, seconded by Louis Richard, the following resolution was introduced and adopted;

**RESOLUTION NO. 09-154**

**A RESOLUTION ACCEPTING THE QUOTE OF VESCO TENNIS COURTS, INC. IN THE AMOUNT OF TWELVE THOUSAND FOUR HUNDRED SEVENTY-SEVEN DOLLARS (\$12,477.00) FOR THE REPAIR AND RESURFACING OF THE TENNIS COURTS LOCATED IN CHOCTAW AND KRAMER AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER ASSOCIATED DOCUMENTS.**

**WHEREAS**, a contractor attempted to fix the tennis court slabs in 2008, but the work did not produce a desired result by the Parish; and

**WHEREAS**, this project is budgeted in the 2009 Lafourche Parish Government Capital Outlay Budget for Chackbay/Bayou Bouef Tennis Court Project ; and

**WHEREAS**, Vesco Tennis Courts, Inc. submitted a proposal to resurface both courts at a total cost of \$12,477.00; and

**WHEREAS**, this resolution was sponsored for the Administration by Mr. Michael Delatte, Councilman, District 2; and

**WHEREAS**, it is the recommendation of the Administration that the quote of Vesco Tennis Courts, Inc. be accepted; and

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on April 28, 2009, and does hereby accept the bid of Twelve thousand four hundred seventy-seven dollars (\$12,477.00) by Vesco Tennis Courts, Inc.; and authorizes the Parish President to sign, execute and administer all related documents.

**BE IT FURTHER RESOLVED**, that a certified copy of this Resolution shall be forwarded to Vesco Tennis Courts, Inc. (P.O. Box 980, Slidell, LA 70459); Department of Parks, Recreation & Public Facilities; Lafourche Parish Finance Department, and the Parish Administrator.
