

On motion by Lindel Toups, seconded by Joe Fertitta, the following resolution was introduced and adopted;

RESOLUTION NO. 09-156

A RESOLUTION ACCEPTING THE LOW BID FROM HUEY STOCKSTILL, INC. IN THE AMOUNT OF \$770,873.50 FOR THE PROJECT ENTITLED FARM TO MARKET ROAD (RACELAND SUGARS (PHASES A AND B), GHEENS SHORTCUT ROAD (PHASE A), AND RACELAND SR. CITIZENS PARKING LOT), AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID CONTRACT AND ASSOCIATED DOCUMENTS.

WHEREAS, the Engineer for this project, T. Baker Smith, Inc. legally advertised the project in the official journal; and

WHEREAS, the bids were received and read publicly on April 21, 2009 as follows:

Barriere Construction Co. LLC	\$861,543.50
Huey Stockstill, Inc.	\$770,873.50

WHEREAS, the low bidder is Huey Stockstill, Inc. in the amount of \$770,873.50; and

WHEREAS, it is the recommendation of T. Baker Smith Inc., and the Administration of Lafourche Parish Government that the low bid of Huey Stockstill, Inc. be accepted; and

WHEREAS, this resolution was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on April 28, 2009, and does hereby accept and approve the bid of Huey Stockstill, Inc. in the amount of \$770,873.50 for the project entitled Farm to Market Road (Raceland Sugars (Phases A and B), Gheens Shortcut Road (Phase A), and Raceland Sr. Citizens Parking Lot), and authorizes the Parish President to sign, execute, and administer said contract and all related documents.

BE IT FURTHER RESOLVED, that a certified copy of this Resolution shall be forwarded to T. Baker Smith, Inc. (1100 South Acadia Road, Thibodaux, LA 70301); Lafourche Parish Government Department of Public Works; Department of Finance, and the Office of the Parish Administrator.
