RESOLUTION APPOINTING ONE (1) COMMISSIONER TO REPRESENT THE RECOGNIZED CULTURAL/HISTORICAL ORGANIZATION TO THE LAFOURCHE PARISH TOURIST COMMISSION.

WHEREAS, Lafourche Parish Tourist Commission has one vacancy which occurred from a resignation representing the recognized Cultural/Historical Organization; and

WHEREAS, Ms. Marjorie Barker resigned on June 27, 2008 from the Lafourche Parish Tourist Commission; and

WHEREAS, the Lafourche Heritage Society, Inc. submitted Dr. John Doucet as its recommendation to Lafourche Parish Tourists Commission; and

WHEREAS, this resolution was sponsored for Administration by Mr. Matt Matherne, Councilman, District 5; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this recommendation.
