

On motion by Louis Richard, seconded by Joe Fertitta, the following resolution was introduced and adopted;

RESOLUTION NO. 09-175

A RESOLUTION ACCEPTING THE LOW BID OF RANDY LANDRY CONSTRUCTION, LLC IN THE AMOUNT OF TWO HUNDRED THIRTEEN THOUSAND SEVEN HUNDRED TWENTY-SEVEN DOLLARS (\$213,727.00) FOR REPAIRS AND RENOVATIONS TO THE HISTORIC COURTHOUSE IN DOWNTOWN THIBODAUX AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ALL ASSOCIATED DOCUMENTS.

WHEREAS, due to the effects of Hurricane Gustav, the Historic Courthouse had a mold infestation which required remediation; and

WHEREAS, the mold remediation process required the removal of many permanent items such as sheetrock, carpet, ceiling tiles, etc.; and

WHEREAS, in addition to storm repairs, there are several areas of the Courthouse that need renovation work; and

WHEREAS, five (5) bids were received and read publicly on April 8, 2009 as follows:

B.E.T. Construction, Inc.	\$277,175.00
Bonneval Construction, Inc.	\$329,000.00
M & H Builders, Inc.	\$253,500.00
Thomassie Construction, Inc.	\$249,500.00
Randy Landry Construction, LLC	\$213,727.00

WHEREAS, it is the recommendation of Project Architect Richard Weimer, of Richard Weimer Architect, AIA – LLC, that the bid of Randy Landry Construction, LLC be accepted; and

WHEREAS, this resolution was sponsored for Administration by Mr. Louis Richard, Councilman, District 3; and

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on May 12, 2009, and does hereby accept the bid of two hundred thirteen thousand seven hundred twenty-seven dollars (\$213,727.00) by Randy Landry Construction, LLC; and authorizes the Parish President to sign, execute, and administer all related documents.

BE IT FURTHER RESOLVED, that a certified copy of this Resolution shall be forwarded to Randy Landry Construction, LLC (300 Emerald Park Drive, Thibodaux, LA 70301); Richard Weimer, Architect AIA – LLC (P.O. Box 229, Thibodaux, LA 70302); Lafourche Parish Government Department of Parks, Recreation & Public Facilities, Finance Department, and the Office of the Parish Administrator.
