RESOLUTION APPROVING THE DEMOLITION OF THE RITA BRIDGE AND THE INSTALLATION OF A RAIL CAR AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ALL RELEVANT DOCUMENTS.

WHEREAS, Two bids were received and read publicly on April 27, 2009 as follows; and

WHEREAS, this was approved in the 2009 Capital Projects Budget; and

WHEREAS, this resolution was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approves said demolition of the Rita Bridge and the installation of a rail car from Sea Level Construction for a total of \$63,750.00 and authorizing the Parish President to sign, execute, and administer any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on May 12, 2009, and does hereby authorize the demolition of the Rita Bridge and installation of a rail car from Sea Level Construction for a total of \$63,750.00 and authorizing the Parish President to sign, execute, and administer any and all relevant documents.
