

On motion by Michael Delatte, seconded by Phillip Gouaux, the following resolution was introduced and adopted;

**RESOLUTION NO. 09-185**

**RESOLUTION AUTHORIZING THE PROCUREMENT OF AN ADMINISTRATIVE CONSULTANT TO COMPLETE ALL ADMINISTRATIVE SERVICES REQUIRED IN THE IMPLEMENTATION OF THE LAFOURCHE PARISH HURRICANE GUSTAV/IKE COMMUNITY DEVELOPMENT BLOCK GRANT – DISASTER RECOVERY PROGRAM.**

**WHEREAS**, Lafourche Parish Government has been notified of its allocation of \$33,000,000 in Hurricane Gustav/Ike Disaster Recovery funds to implement projects that will aid in the recovery from these two (2) devastating storm events; and

**WHEREAS**, implementation of the Disaster Recovery Program requires Lafourche Parish Government to strictly adhere to the myriad of federal regulations governing the use of Community Development Block Grant (CDBG) funds; and

**WHEREAS**, to ensure successful implementation of the Lafourche Parish Disaster Recovery Program, the procurement of a qualified Administrative Consultant to facilitate program implementation in accordance with Federal and State requirements is required.

**WHEREAS**, this resolution was sponsored for Administration by Mr. Michael Delatte, Councilman, District 2; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council authorize the Parish President to procure an Administrative Consultant.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on May 26, 2009, and does hereby authorize the Parish President to procure an Administrative Consultant to complete all Administrative services required in the implementation of the Lafourche Parish Hurricane Gustav/Ike Community Development Block Grant – Disaster Recovery Program.

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution shall be forwarded to the Office of the Parish Administrator and to the Grants & Economic Development Department.
