A RESOLUTION ACCEPTING THE LOW BID FOR WEST 25TH STREET DRAINAGE PROJECT – 2009 AWARDED BOTH THE BASE BID AND ADDITIVE ALTERNATE BID WITH THE LOW BID BEING SUBMITTED BY SEALEVEL CONSTRUCTION, INC., IN THE AMOUNT OF \$218,656.00 AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID CONTRACT AND ASSOCIATED DOCUMENTS.

WHEREAS, ten (10) bids were received and read publicly on April 30, 2009 with the two lowest bidders as follows:

WHEREAS, this project was approved in the 2009 Capital Project detail to be funded by RSTD II Revenue and Royalty; and

WHEREAS, it is the recommendation of J. Wayne Plaisance and the Administration of Lafourche Parish Government that the low bid of \$218,656.00 be accepted; and

WHEREAS, this resolution was sponsored for Administration by Mr. Rodney Doucet, Councilman, District 8; and

WHEREAS, it is recommended by the Administration that the Lafourche Parish Council accept the low bid of \$218,656.00 from Sealevel Construction, Inc. and authorizes the Parish President to sign, execute, and administer said contract and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on May 26, 2009 and does hereby accept and approve the low bid of \$218,656.00 from Sealevel Construction, Inc. and authorizes the Parish President to sign, execute, and administer said contract and any and all related documents.
