**RESOLUTION NO. 09-190**

**RESOLUTION ADOPTING THE CITIZEN PARTICIPATION PLAN FOR IMPLEMENTATION IN THE LCDBG AND/OR HURRICANE GUSTAV/IKE COMMUNITY DEVELOPMENT BLOCK GRANT – DISASTER RECOVERY PROGRAM.**

**WHEREAS**, participation in the Hurricane Gustav/Ike Community Development Block Grant (CDBG) – Disaster Recovery Program requires the adoption and implementation of a Citizen Participation Plan to comply with Section 508 of the Housing and Community Development Act of 1974, as amended; and

**WHEREAS**, the purpose of this plan is to provide for and encourage citizen participation with particular emphasis on participation by persons of low and moderate income who are residents of slum and blighted areas and of areas in which funds are proposed to be used; and

**WHEREAS**, the Parish has previously enacted a Citizen Participation Plan with regard to LCDBG programs, and

**WHEREAS**, the Parish desires to update its Citizen Participation Plan to ensure it meets the standards of both the LCDBG and the CDBG Disaster Recovery programs.

**WHEREAS**, this resolution was sponsored for Administration by Mr. Michael Delatte, Councilman, District 2; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council adopt the attached Citizen Participation Plan in connection with its Louisiana Community Development Block Grant (LCDBG) and CDBG Disaster Recovery Program applications.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on May 26, 2009, and does hereby adopt the attached Citizen Participation Plan in connection with its Louisiana Community Development Block Grant (LCDBG) and CDBG Disaster Recovery Program applications.

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution shall be forwarded to the Office of the Parish Administrator and to the Grants & Economic Development Department.
