

On motion by Rodney Doucet, seconded by Daniel Lorraine, the following resolution was introduced and adopted;

RESOLUTION NO. 09-196

RESOLUTION APPROVING THE PURCHASE OF ONE HUNDRED SEVENTY FOUR FEET OF 66", 10 GAUGE, ARCHED CULVERTS FOR EAST 48TH, EAST 49TH, EAST 51ST, EAST 52ND AND NORTH EAST 52ND TO IMPROVE DRAINAGE IN THE RESPECTIVE AREA; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ALL RELEVANT DOCUMENTS.

WHEREAS, the purchase of one hundred seventy four feet of 66", 10 gauge, arched culverts for East 48th, East 49th. East 51st, East 52nd and North East 52nd to improve drainage in the respective area; and

WHEREAS, three quotes were received as follows:

Alan J. Arcement	\$19,009.50
Allemand's Culverts, LLC	\$25,665.00
Lockport Farm Market	\$23,098.52

WHEREAS, Alan J Arcement was the lowest quote in the amount of \$19,009.50; and

WHEREAS, this purchase is to replace smashed culverts and help with drainage and water flow; and

WHEREAS, this resolution was sponsored for Administration by Mr. Rodney Doucet, Councilman, District 8; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approves said purchase of culverts from Alan J Arcement for a total of \$19,009.50 and authorizes the Parish President to sign, execute, and administer any and all relevant documents.

THEREFORE BE IT RESOLVED, that the Lafourche Parish Council convened in special session on June 3, 2009, and does hereby authorize the purchase of one hundred seventy four feet of 66", 10 gauge, arched culverts for East 48th, East 49th. East 51st, East 52nd and North East 52nd to improve drainage in the respective area for a total of \$19,009.50 and authorizes the Parish President to sign, execute, and administer any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this Resolution shall be forwarded to the Lafourche Parish Government Department of Public Works; Department of Finance, and the Office of the Parish Administrator.
