RESOLUTION NO. 09-203

RESOLUTION APPOINTING TWO (2) COMMISSIONERS TO THE VETERANS' MEMORIAL DISTRICT OF WARD 10 OF LAFOURCHE PARISH BOARD.

WHEREAS, Mr. Willis Toups and Mr. Donald Callais, served on the Veterans' Memorial District of Ward 10 of Lafourche Parish Board representing the Anthony N. Griffin American Legion Post 259; and

WHEREAS, according to the Lafourche Parish Government's records, Mr. Willis Toups and Mr. Donald Callais had terms which expired; and

WHEREAS, according to State law which created the Veterans' Memorial District of Ward 10 of Lafourche Parish Board, the Anthony N. Griffin American Legion Post 259 in Golden Meadow shall submit four (4) names and the Council shall select and appoint two (2) members from the list submitted by each post; and

WHEREAS, the Anthony N. Griffin American Legion Post 259 recommended Willis Toups, Donald Callais, Oris J. Cheramie or Louis Lee be appointed to represent the Anthony N. Griffin American Legion Post 259 on the Veterans' Memorial District of Ward 10 of Lafourche Parish Board; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this recommendation.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on June 9, 2009, and does hereby appoint Willis Toups and Donald Callais to serve a three (3) year term beginning June 9, 2009 and ending June 8, 2012, to the Veterans' Memorial District of Ward 10 of Lafourche Parish Board.
