

On motion by Michael Delatte, seconded by Louis Richard, the following resolution was introduced and adopted;

**RESOLUTION NO. 09-208**

**RESOLUTION APPOINTING ONE (1) COMMISSIONER TO THE LAFOURCHE PARISH HEROES MONUMENT COMMISSION.**

**WHEREAS**, Ordinance No. 4360, adopted at the August 12, 2008 meeting of the Lafourche Parish Council, created the Heroes Monument Commission; and

**WHEREAS**, the Commission is comprised of nine (9) members, all which shall be electors domiciled outside of Ward 10; and five (5) of which shall be Honorably Discharged Veterans of a Branch of the U. S. Armed Forces; two (2) members shall have been employed as a Commission Police Officer for a minimum of five years; and two (2) members shall have served as a Fireman for a minimum of five years; and

**WHEREAS**, these positions were advertised and John Michael Waguespack, submitted an application to fill one (1) position for a member who served as a Commission Police Officer for a minimum of five (5) years

**WHEREAS**, this resolution was sponsored for Administration by Mr. Michael Delatte, District 2; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council take action on this vacancy.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on June 9, 2009, and does hereby appoint to the Lafourche Parish Heroes Monument Commission Mr. John Michael Waguespack as a Commission Police Officer to serve an initial five (5) year term beginning June 9, 2009 and ending June 8, 2014.

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution shall be forwarded to Mr. John Michael Waguespack, 2589 Talbot Avenue, Thibodaux, LA 70301; and the Office of Grants and Economic Development.
