RESOLUTION NO. 09-209

A RESOLUTION ACCEPTING THE QUOTE FROM GOLDEN RANCH AVIATION FOR AERIAL SPRAYING OF THE CANALS AND RESERVOIRS THROUGHOUT LAFOURCHE PARISH AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE AND ADMINISTER ASSOCIATED DOCUMENTS.

WHEREAS, four (4) quotes were requested for aerial spraying of canals and reservoirs throughout the parish; and

WHEREAS, one (1) quote was received from Golden Ranch Aviation in which the fees will consist of the following:

Aquatic Vegetation	\$ 625.00 per mile
Cut Grass	\$ 725.00 per mile
Trees and Undesirable Brush	\$1,025.00 per mile

**including chemicals, personnel and equipment to ensure precise coverage and control of the vegetation*

WHEREAS, Golden Ranch Aviation will guarantee a 90% kill on said vegetation; and

WHEREAS, all Field Office Supervisors submitted areas that are in need of spraying; and

WHEREAS, funds are budgeted in the 2009 Drainage Fund; and

WHEREAS, this resolution was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on June 9, 2009, and does hereby accept the quote from Golden Ranch Aviation, and authorizes the Parish President to sign, execute, and administer all related documents.

BE IT FURTHER RESOLVED, that a certified copy of this Resolution shall be forwarded to Golden Ranch Aviation, P. O. Box 280, Raceland, LA 70394; Lafourche Parish Government Department of Public Works; Finance Department, and the Office Parish Administrator.
