RESOLUTION NO. 09-214

RESOLUTION AMENDING RESOLUTION NO. 09-064 APPROVING AN AGREEMENT FOR PROFESSIONAL SERVICES BETWEEN DUPLANTIS DESIGN GROUP AND LAFORCHE PARISH TO PROVIDE DETAILED REPAIRS AND ESTIMATES FOR THE BARRIOS BUILDING; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ANY ASSOCIATED DOCUMENT(S).

WHEREAS, FEMA requested additional information on the estimates for roof repairs needed at the Barrios Building for the purposes of completing the Project Worksheet which caused an increase in fees; and

WHEREAS, this documentation included detailed architectural drawings of the building to pinpoint damaged areas and cost estimates for repairs; and

WHEREAS, this documentation for Phase 2 was necessary to complete the Project Worksheet on the Barrios Building, and is necessary not only for FEMA but also for insurance purposes; and

WHEREAS, fees associated for these services will be reimbursed by the insurance company; and

WHEREAS, this amendment is necessary to provide additional services as required by FEMA and Lafourche Parish Government to document damage to the Barrios Building as a result of Hurricane Gustav with additional services estimating \$2,600.00; and

WHEREAS, the lump sum fee of \$23,400.00 is the total cost for the services rendered; and

WHEREAS, the resolution was sponsored for Administration by Mr. Lindel Toups, Councilman, District 6; and

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on June 9, 2009, and does hereby approve **said amendment to Resolution No. 09-064 hiring Duplantis Design Group to provide detailed repairs and estimates for the Barrios Building with additional services estimating \$2,600.00**; and authorizes the Parish President to sign, execute and administer any associated document(s).

BE IT FURTHER RESOLVED, that a certified copy of this Resolution shall be forwarded to Duplantis Design Group (314 East Bayou Road, Thibodaux, LA 70301); Department of Parks, Recreation & Public Facilities; Lafourche Parish Finance Department, and the Office of the Parish Administrator.
