**RESOLUTION NO. 09-216**

**RESOLUTION APPROVING THE PURCHASE OF FIFTEEN (15) PORTABLE MOTOROLA RADIOS FOR THE DEPARTMENT OF PUBLIC WORKS AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ALL RELEVANT DOCUMENTS.**

**WHEREAS**, the 15 Portable Motorola Radios XTS 2500 Model II will be purchased from Motorola Communications at a cost of Two Thousand Two Hundred Fifty Four Dollars and Fifty Cents (\$2,254.50) each for a total cost of Thirty Three Thousand Eight Hundred Seventeen and Fifty Cents (\$33,817.50); and

**WHEREAS**, the following will be purchased according to LA. R.S. 39:1702 and R.S. 39:1708 with Jefferson Parish through a Cooperative Purchasing Agreement; and

**WHEREAS**, all funds have been allocated within the Roads and Bridges Fund in the 2009 Operating Budget; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Joe Fertitta, Councilman, District 4; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council approves said purchase of fifteen (15) Portable Motorola Radios XTS 2500 Model II, for a total of \$33,817.50 and authorizes the Parish President to sign, execute, and administer any and all relevant documents.

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on June 23, 2009, and does hereby authorize the purchase of fifteen (15) Portable Motorola Radios XTS 2500 Model II, for a total of \$33,817.50 and authorizes the Parish President to sign, execute, and administer any and all relevant documents.

**BE IT FURTHER RESOLVED**, that a certified copy of this Resolution shall be forwarded to the Lafourche Parish Government Department of Public Works; Department of Finance, and the Office of the Parish Administrator.
