**RESOLUTION AUTHORIZING FIVE (5) LAFOURCHE PARISH
GOVERNMENT EMPLOYEES TO PURCHASE SURPLUS STATE
PROPERTY FROM LOUISIANA PROPERTY ASSISTANCE AGENCY AND
AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND
ADMINISTER SAID DOCUMENTS**

WHEREAS, Lafourche Parish has the opportunity to purchase surplus State property from Louisiana Property Assistance Agency a Division of the Administration of the State of Louisiana; and

WHEREAS, Five (5) employees were requested to be designated as representatives of Lafourche Parish Government to purchase State surplus property from Louisiana Property Assistance Agency; and

WHEREAS, it is the recommendation of the Administration to authorize, Crystal Chiasson, Chris Boudreaux, Terry Arabie, Gary Washington and Glenn Bourgeois to purchase surplus property from Louisiana Property Assistance Agency; and

WHEREAS, this resolution was sponsored for Administration by Mr. Michael Delatte, Councilman, District 2; and

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on June 23, 2009, and does hereby authorize Crystal Chiasson, Chris Boudreaux, Terry Arabie, Gary Washington and Glenn Bourgeois to purchase surplus State property from Louisiana Property Assistance Agency.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to Chris Boudreaux, Director of Emergency Preparedness, Terry Arabie, Project Manager, Gary Washington, Area Supervisor North, Glenn Bourgeois, Area Supervisor South; and the Lafourche Parish Government Office of the Parish Administrator.
