

On motion by Lindel Toups, seconded by Phillip Gouaux, the following resolution was introduced and adopted;

RESOLUTION NO. 09-222

RESOLUTION APPROVING CHANGE ORDER NO. 1 FOR ADDITIONAL WELDING ON THE RAIL CAR FOR THE RITA BRIDGE RESULTING IN AN INCREASE IN THE CONTRACT PRICE BY \$650.00; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID CHANGE ORDER AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, additional welding is needed to the rail car for the Rita Bridge in order to insure that the rail car strength and integrity is adequate; and

WHEREAS, the original contract price of \$63,750.00 will be increased by this Change Order in the amount of \$650.00 for a new contract price totaling \$64,400.00; and

WHEREAS, it is the recommendation of Lafourche Parish Government Department of Public Works and Sealevel Construction, Inc. that said Change Order be accepted; and

WHEREAS, this resolution was sponsored for the Administration by Mr. Lindel Toups, Councilman, District 6; and

WHEREAS, it is recommended by the Administration of Lafourche Parish Government that the Council approve said Change Order and authorizes the Parish President to sign, execute, and administer said Change Order and any and all relevant documents.

BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on June 23, 2009, and does hereby approve Change Order No. 1 for an increase in contract price by six hundred fifty dollars (\$650.00) for additional welding on rail car for the Rita Bridge; and does hereby authorize the Parish President to sign said Change Order and any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this resolution shall be forwarded to Sealevel Construction, Inc., P. O. Box 655, Thibodaux, LA 70302; Department of Public Works; Department of Finance and the Office of the Parish Administrator.
