**RESOLUTION NO. 09-248**

**A RESOLUTION ACCEPTING THE LOW QUOTE OF LOW LAND CONSTRUCTION CO., INC. IN THE AMOUNT OF SIXTY THOUSAND DOLLARS (\$60,000.00) FOR CONCRETE RAMPS AT THE BILL TAYLOR BOAT LAUNCH AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER ANY AND ALL ASSOCIATED DOCUMENTS.**

**WHEREAS**, the 2009 Capital Outlay budget contains funding for concrete ramps for the Bill Taylor Boat Launch; and

**WHEREAS**, three (3) quotes were requested from contractors and were received as follows:

Low Land Construction	\$60,000.00
Phylway Construction	\$88,250.00
B.E.T. Construction	<i>(declined to quote price on project at this time)</i>

**WHEREAS**, this resolution was sponsored for Administration by Mr. Michael Delatte, Councilman, District 2; and

**WHEREAS**, it is the recommendation of the Administration that the quote of Low Land Construction Co., Inc. be accepted; and

**THEREFORE, BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on July 14, 2009, and does hereby accept the quote of sixty thousand dollars (\$60,000.00) by Low Land Construction Co., Inc.; and authorizes the Parish President to sign, execute, and administer any and all related documents.

**BE IT FURTHER RESOLVED**, that a certified copy of this Resolution shall be forwarded to Low Land Construction Co., Inc. 946 Lefort By-pass Road, Thibodaux, LA 70301; Department of Parks, Recreation & Public Facilities; Lafourche Parish Finance Department, and the Office of the Parish Administrator.
