RESOLUTION ACCEPTING THE LOW BID FROM DOLPHIN SERVICES, INC. IN THE AMOUNT OF \$1,933,857.80 FOR REPAIRS TO THE COTE BLANCHE BRIDGE AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER A CONTRACT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approves the low bid from Dolphin Services, Inc. for repairs to the Cote Blanche Bridge in the amount of \$1,933,857.80 and authorizes the Parish President to sign, execute, and administer said contract and any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on July 14, 2009, and does hereby approve the low bid from Dolphin Services, Inc. for repairs to the Cote Blanche Bridge in the amount of \$1,933,857.80 and authorizes the Parish President to sign, execute, and administer said contract and any and all relevant documents.
