

On motion by Louis Richard, seconded by Daniel Lorraine, the following resolution was introduced and adopted;

RESOLUTION NO. 09-256

RESOLUTION APPROVING CHANGE ORDER NO. 1 TO RANDY LANDRY CONSTRUCTION, LLC AS AN INCREASE IN CONTRACT PRICE BY \$4,632.20 FOR ADDITIONAL WORK ON THE HISTORIC COURTHOUSE REPAIRS AND RENOVATIONS PROJECT; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN SAID CHANGE ORDER AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, the original contract price was \$213,727.00; and

WHEREAS, more work is required after discoveries were made during the contracted work (see attached); and

WHEREAS, some other minor additional work has been requested by the judges; and

WHEREAS, this Change Order No. 1 increases the contract price by \$4,632.20 totaling a new contract price of \$218,359.20; and

WHEREAS, it is the recommendation of Richard Weimer, Architect AIA - LLC that said Change Order be accepted; and

BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on July 14, 2009, and does hereby approve a Change Order No. 1 to Randy Landry Construction, LLC as an increase in contract price by price by \$4,632.20 for additional work on the Historic Courthouse Repairs and Renovations Project; and does hereby authorize the Parish President to sign said Change Order.

BE IT FURTHER RESOLVED, that a certified copy of this Resolution shall be forwarded to Randy Landry Construction, LLC, 300 Emerald Park Drive, Thibodaux, LA 70301; Richard Weimer, Architect AIA – LLC, P.O. Box 229, Thibodaux, LA 70302; Department of Parks, Recreation & Public Facilities, Lafourche Parish Finance Department, and the Parish Administrator.
