

On motion by Daniel Lorraine, seconded by Michael Delatte, the following resolution was introduced and adopted;

RESOLUTION NO. 09-257

RESOLUTION APPROVING CHANGE ORDER NO. 2 FOR THE PROJECT ENTITLED “ROADWAY AND DRAINAGE IMPROVEMENTS IN ROAD SALES TAX DISTRICT NO. 2, PROJECT 4E – GOLDEN MEADOW STREETS” FOR AN INCREASE IN CONTRACT PRICE BY ~~\$19,980.00~~ \$36,597.00 AND AN INCREASE IN CONTRACT TIME BY ~~7~~ 14 CALENDAR DAYS; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID CHANGE ORDER AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, this Change Order is being presented to replace 148’ of culverts from the 7’x8’ catch basin on the east side of Norman Street to the outfall ditch behind Golden Meadow Elementary; and to replace 131’ of additional side culverts and catch basins on St. Louis Street; and

WHEREAS, the original contract price is \$1,443,574.60 which was adjusted by a previous Change Order totaling \$1,618,648.10; and

WHEREAS, this Change Order will increase the contract price by ~~\$19,980.00~~ \$36,594.00 for a new contract price totaling ~~\$1,638,628.10~~ \$1,655,245.10; and

WHEREAS, addition of this new work will necessitate a ~~7~~ 14 day contract extension; and

WHEREAS, it is the recommendation of Picciola & Associates, Inc. and this Administration that said Change Order be accepted; and

WHEREAS, this resolution was sponsored for Administration by Mr. Daniel Lorraine, Councilman, District 9; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council authorize the Parish President to sign said Change Order and execute and administer any and all relevant documents.

BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on July 14, 2009, and does hereby approve Amended Change Order No. 2 for Roadway and Drainage Improvements in Road Sales Tax District No. 2, Project 4E – Golden Meadow Streets, and authorizing the Parish President to sign said Change Order and execute and administer any and all relevant documents.

BE IT FURTHER RESOLVED, that a certified copy of this Resolution shall be forwarded to Picciola & Associates, Inc., P.O. Box 687, Cut Off, LA 70345; Lafourche Parish Government Department of Finance; and the Office of the Parish Administrator.
