RESOLUTION ACCEPTING THE BID FROM THIRD COAST ELECTRICAL SERVICES, LLC FOR ELECTRICAL WORK ON THE GALLIANO PONTOON BRIDGE IN THE AMOUNT OF \$249,599.79 AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER A CONTRACT AND ANY AND ALL RELEVANT DOCUMENTS.

WHEREAS, one bid was received from Third Coast Electrical Services, LLC (as attached) in the amount of \$249,599.79; and

WHEREAS, this resolution was sponsored for Administration by Mr. Daniel Lorraine, Councilman, District 9; and

WHEREAS, it is recommended by the Administration of the Lafourche Parish Government that the Council approves the bid from Third Coast Electrical Services, LLC for electrical repairs to the Galliano Pontoon Bridge in the amount of \$249,599.79 and authorizes the Parish President to sign, execute, and administer any and all relevant documents.

THEREFORE, BE IT RESOLVED, that the Lafourche Parish Council convened in regular session on July 14, 2009, and does hereby approve and accept the bid from Third Coast Electrical Services, LLC for electrical repairs to the Galliano Pontoon Bridge in the amount of \$249,599.79 and authorizes the Parish President to sign, execute, and administer any and all relevant documents.
