**RESOLUTION NO. 09-273**

**RESOLUTION APPROVING CHANGE ORDER NO. 1 FROM BOLLINGER LAROSE, LLC FOR WORK ON THE GALLIANO BRIDGE, INCREASING THE CONTRACT PRICE BY \$69,263.85; AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID CHANGE ORDER AND ANY AND ALL RELEVANT DOCUMENTS.**

**WHEREAS**, this additional work was not included in the bid for the Galliano Bridge; and

**WHEREAS**, in order to insure the project's completion, Change Order No. 1 is necessary; and

**WHEREAS**, the original contract price of \$130,225.00 will be increased by this Change Order in the amount of \$69,263.85 for a new contract price totaling \$199,488.85; and

**WHEREAS**, it is the recommendation of Lafourche Parish Government Department of Public Works and Bollinger Larose, LLC that said Change Order be accepted; and

**WHEREAS**, this resolution was sponsored for the Administration by Mr. Daniel Lorraine, Councilman, District 9; and

**WHEREAS**, it is recommended by the Administration of Lafourche Parish Government that the Council approve said Change Order and authorizes the Parish President to sign, execute, and administer said Change Order and any and all relevant documents.

**BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on July 28, 2009, and does hereby approve Change Order No. 1 for an increase in contract price by \$69,263.85 for additional work on the Galliano Bridge; and does hereby authorize the Parish President to sign said Change Order and any and all relevant documents.

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution shall be forwarded to Bollinger Larose, LLC, P. O. Box 1410, Larose, LA 70373; Department of Public Works; Department of Finance and the Office of the Parish Administrator.
