**RESOLUTION NO. 09-283**

**RESOLUTION RESCINDING RESOLUTION NO. 08-275 THAT ACCEPTED THE LOW BID OF ANDREW BAUDOIN BUILDING CONTRACTOR IN THE AMOUNT OF SIX THOUSAND FOUR HUNDRED AND FORTY DOLLARS (\$6,440.00) FOR CONTRACTOR SERVICES RELATED TO THE NUISANCE ABATEMENT ORDINANCE NO. 3605 CONCERNING THE DEMOLITION OF A CONDEMNED STRUCTURE LOCATED AT 240 BAYOU BLUE BYPASS ROAD, ASSESSMENT #0110775700, AND APPROVING CONTRACT(S) FOR SAID CONTRACTOR SERVICE WORK AND AUTHORIZING THE PARISH PRESIDENT TO SIGN, EXECUTE, AND ADMINISTER SAID CONTRACT(S) AND ALL RELEVANT DOCUMENTS AND AMENDMENTS.**

**WHEREAS**, an inspection was done on April 22, 2009 indicating that the said property was in compliance with the Nuisance Ordinance; and

**WHEREAS**, no further action will be required on said property; and

**WHEREAS**, this resolution was sponsored for Administration by Mr. Phillip Gouaux Councilman, District 7; and

**WHEREAS**, it is recommended by the Administration of the Lafourche Parish Government that the Council hereby rescinds in its entirety Resolution No.08-275

**THEREFORE BE IT RESOLVED**, that the Lafourche Parish Council convened in regular session on August 11, 2009, and does hereby rescind in its entirety Resolution No. 08-275 that accepted the low bid of Andrew Baudoin Building Contractor in the amount of six thousand four hundred and forty dollars (\$6,440.00) for contractor services related to the nuisance abatement Ordinance No. 3605 concerning the demolition of condemned structure located at 240 Bayou Blue Bypass Road, Assessment #0110775700, and approving contract(s) for said contractor service work and authorizing the Parish President to sign, execute, and administer any and all relevant documents.
